Senate Minutes March 21, 2003

S.03-48 <u>Minutes of the Previous Meeting</u>

The minutes of the meeting of February 21, 2003, were approved as circulated.

REPORT OF THE PRESIDENT

S.03-49 War in the Middle East: Respect and Tolerance on Campus

Dr. Davenport read the following statement to Senate:

The outbreak of war in the Middle East carries with it two distinct dangers for those of us on Western's campus. For those with loved ones in the area there is a special danger, and our thoughts and prayers go out to all in our community who find themselves in that terrible situation.

A second sort of danger concerns the environment of respect and tolerance which is critical to the free speech and free enquiry of a university campus. Western students, staff, and faculty have worked hard to maintain a climate of mutual respect in our community during a period of growing international tensions. We have been able to express and listen to strongly divergent opinions on issues we feel passionately about while maintaining a campus environment where all may feel safe, secure, and respected. At this time of international conflict, we must redouble our efforts to preserve that environment of safety and tolerance, in which even sharp disagreement over political and social issues must never involve bigotry or discrimination against racial or religious groups. We may take some pride in the environment of tolerance and respect on our campus; let us work together to preserve that environment, so important to the teaching and research of a great university.

S.03-55 <u>BESc/LLB Concurrent Degree Program (Electrical Engineering/Law) and Electrical Engineering and Law Option</u>

On behalf of SCAPA, it was moved by B. Timney, seconded by S. Osborn,

That effective, September 1, 2003, a six-year limited enrolment concurrent degree program leading to a BESc (Electrical Engineering) and LLB, detailed in Exhibit III, item 1, be introduced by the Faculty of Engineering and the Faculty of Law, and that a third option, Option D: Electrical Engineering and Law, be established for the Department of Electrical and Computer Engineering.

S.03-56 Admission Requirements: The Western-Fanshawe Collaborative BScN Program

That, effective September 1, 2003, Grade 12 U Math - Geometry and Discrete Math no longer be a recommended course for students applying for admission to the Western-Fanshawe Collaborative BScN Program.

That effective September 1, 2003, a Minor in National Cinemas, detailed in Exhibit III, item 3, be introduced in the Faculty of Arts.

S.03-58 Student Access to Examination Papers and Other Work

It was moved by B. Timney, seconded by M. Huston,

That the policy on Student Access to Examination Papers and Other Work be revised to ensure that: 1) student work is not left unattended and 2) instructors retain complete records of students' work for the twelve month retention period.

STUDENT ACCESS TO EXAMINATION PAPERS AND OTHER WORK (S.2507, S.3326, S.89-176)

In the event that a student requests it, an instructor shall produce and review* with the student all papers (final examination or other) not returned to the student and for which a mark has been assigned. A student who has appealed in writing to a departmental chair (or dean in faculties without departmental structure) shall be granted access, upon his or her request, to such papers under supervisory arrangements established by the appropriate dean.

*In the course of this review, the student shall be entitled to see the paper.

[Note: Students are reminded that there are deadlines for submitting requests for relief. See Academic Rights and Responsibilities section of the Calendar.]

Submitting or Returning Student Assignments, Tests and Exams or Other Evaluated Work All student assignments, tests and exams will be handled in a secure and confidential manner. Particularly in this respect, leaving student work unattended in public areas for pickup is not permitted.

Retention of Examination Papers and Records

Departments (or Faculties without departmental structure) shall require all instructors to maintain complete records of all marks/grades (and their relative weights) for individual assignments, tests, etc., which are used in calculating the final overall mark/grade in a course for a period of twelve calendar months from the date of the last regularly scheduled class of a course.

Departments (or Faculties without departmental structure) shall retain all papers (final examination or otherwise), which have not been returned to the student and for which a mark has been assigned, for a period of eight months from the date of the last regularly scheduled class in a course. Department chairs will make arrangements for storing such papers either with instructors or in a departmental depository. Instructors are expected to provide complete records to the Department or Faculty upon request.

The report of the Academic Colleague on the 264th meeting of the Council of Ontario Universities, detailed in Exhibit V, was received for information. Topics discussed included teaching and research at Ontario universities and the post-secondary education system. In the absence of the Academic Colleague, Dr. Davenport asked that Senators send Dr. McQuillan their ideas on the problem of admissions policy in the light of persistent grade inflation given that a working group of the Academic colleagues is studying the issue.

ENQUIRIES AND NEW BUSINESS

S.03-66 Office of the Vice-Provost (Policy, Planning & Faculty)

Professor Carroll asked for clarification about the need for a Coordinator in the Office of the Vice-Provost (Policy, Planning & Faculty) whose responsibility would involve faculty recruitment and retention. He recalled that Senate last year discussed the creation of a new position, Vice-Provost (Policy, Planning & Faculty). That position was created because the Provost and the Director of Faculty Relations could not handle all the tasks associated with faculty relations. Professor Carroll was critical of the administration for creating yet another new administrative position. He asked who proposed the coordinator position and if that person contests or agrees with the claim that it is the poor salary structure that is the primary cause of Western's recruitment and retention problems.

Dr. Moran recalled that last year when Senate discussed the creation of the position of Vice-Provost (Policy, Planning & Faculty), he informed Senate that staff support would be needed. The Coordinator will provide support to departments and faculties in their effort to attract, recruit and retain faculty members. He disagreed with Professor Carroll's inference that this position was not discussed broadly. Addressing the statement that the problems associated with recruitment and retention of faculty, Dr. Moran said that faculty come and go for various reasons including research and scholarly opportunities not available at Western, and for family reasons. With regard to faculty salaries, the administration's interests are similar to those of faculty members: it would be beneficial to all if Western's salaries were competitive to both attract and retain faculty.

Professor Carroll asked Dr. Moran if he believes Western's salaries are competitive. Dr. Moran replied that generally Western's salaries are extremely competitive in many areas, but comparing salaries is complex. There are no clear ways to compare salaries across universities, given that salaries vary a great deal across disciplines, and age is another factor that must be considered.






