#### S.10-158 MINUTES OF THE PREVIOUS MEETING

The minutes of the meeting of September 24, 2010, were approved with the inclusion of J. Matthews to the attendance list.

#### S.10-159 **REPORT OF THE PRESIDENT**

The Report of the President consisted of the following topics: International partnership, regional partnership, Ivey Leadership Institute, Government relations, and the Federal R&D Review Panel. Overhead slides used to highlight his presentation are attached as **Appendix 1**.

#### S.10-159a **President's Priorities**

Senate received for information the President's Priorities, detailed in the exhibit distributed with the agenda. His priorities aim to advance Western's academic mission under five broad areas of strategic importance: leadership; students; research intensiveness and graduate education; financial accountability; community partnership.

Asked why faculty were not listed as a separate priority, Dr. Chakma said that his intent was to be inclusive of all members of Western's community, and thus did not separately list the various constituencies. Key issues with respect to faculty, including finding the resources to build the talent pool, would be focussed on in the four-year planning process now underway.

A member raised concern about what appeared to be a contradiction within the President's Priorities. On the one hand, the document spoke to the importance of collaboration. While on the other it stressed the need to be competitive. The member believed that the focus on competition had been to the detriment of universities. Dr. Chakma responded that in his view, the two concepts could and did co-exist. The University might enter into a partnership with another institution with which it might compete in another context. He cited CFI developments and the CRC programs as two instances in which competition had been worthwhile.

That effective September 1, 2012, admission to the existing MOS program modules at Brescia University College be discontinued, and that students enrolled in the existing MOS program modules prior to September 1, 2012 be permitted to continue in the module with the understanding that they must complete the requirements prior to September 1, 2016; and, that effective September 1, 2016, all existing MOS program modules (prior to those introduced on September 1, 2012) be withdrawn.
