

### COURSE OUTLINE (SYLLABUS) FOR UNDERGRADUATE COURSE - Biology 4412F/G

**\*\*This course, and other Western courses, will be delivered online until a minimum of January 31<sup>st</sup>.** Students are required to have a computer or laptop, a stable internet connection, and a working webcam and microphone. Students are expected to have cameras on during all online components, and will be required to speak, be on camera, and possibly share their computer screens during some in-class components.

## 3. Course Description/Syllabus

Biodiversity science is an emerging and highly integrative field of research dealing with all aspects of biological diversity. This course will address approaches and techniques for the measurement, assessment, monitoring, and management of biodiversity from genes to ecosystems. We will incorporate social, ecological, and evolutionary perspectives to understand the causes and consequences of biodiversity loss, and the socio-economics of biodiversity change.

As a result of attending integrative lectures / tutorials and successful completion of assigned course work including group projects, students should be able to:

- Articulate verbally and in writing what biodiversity is and the transdisciplinary nature of biodiversity science
- Articulate verbally and in writing the challenges facing the conservation of biodiversity
- Articulate verbally and in writing the dependence of human societies on biodiversity
- Read and critically evaluate scientific and policy literature in biodiversity
- Interpret statistical results as outputs of statistical analyses and in primary scientific literature
- Relate fundamental ecological principles (from both this, and prerequisite courses) to biodiversity concepts and issues
- Contribute substantively and collaboratively to group project documents and presentations

## 4. Course Materials

All course material will be posted to OWL: http://owl.uwo.ca. This is the primary method by which information will be disseminated to all students in the class, and students are responsible for checking OWL on a regular basis. There is no textbook for this course. All lecture and tutorial material will be disseminated in class or posted on OWL.

### **Technical Requirements**

You must have access to a computer with the following:

- Stable internet connection
- Computer (not tablet or phone) with working microphone and webcam
- Office suite with Word, Excel, PowerPoint
- Zoom

#### Notes about course delivery format:

We will use a combination of online and in person classes that will be governed by both government and University health and safety guidelines for Covid, as well as the nature of the inclass activity.

#### 5. Methods of Evaluation

The overall course grade will be calculated from:

- three (3) essays (40%),
- two (2) recorded presentations (20%),
- four (4) group-led structured interviews (20%),
- one group project composed of an in-class activity (10%) and a group presentation (10%).

## Accommodated Evaluations

This course is designated as an F/G course, which means that a minimum of 2500 written words (in essay form) is a compulsory component of the course; <u>you must pass the essay components</u> <u>to pass the course</u>. The written (essay) component is divided among three separate assignments, collectively worth 40% of your final grade. The remaining 60% of your final grade will be derived from in-class activities such as presentations, discussions and structured interviews.

## Information about late or missed evaluations:

All self-reported absences (SRA) should be submitted within 24 hours of the end of the 48-hour period. Students are required to notify the instructor for self-reported absences by the date given in the SRA portal, otherwise the self-reported absence will be considered VOID and you will receive a grade of 0% for the course component indicated.

 $\square$  Late written assignments <u>with</u> self-reported absences (SRA) should be submitted within 24 hours of the end of the 48-hour period.

Missed in-class assignments (including group work, recorded presentations, or where the student is in a lead interview position) with self-reported absences or accommodation cannot be made-up. The weight of any missed in-class assignments will be transferred to Essay #3 (up to an additional assessment value of 15%).

Missed participation in interviews where the student <u>is not</u> in a lead position cannot be madeup nor re-weighted to other course components.

Late assignments of any kind <u>without</u> self-reported absences or accommodations will not be accepted nor re-weighted to other course components.

If more than 40% of the final grade is missed and cannot be made up (i.e. in-class activities including presentations, lead interviews etc.), the student will receive an INC for the course.

### Academic Consideration for Student Absence

Students have up to two (2) opportunities during the regular academic year to use an on-line portal to self-report an absence during the semester, provided the following conditions are met: the absence is no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are required to contact their instructors within 24 hours of the end of the period of the self-reported absence. Students are not able to use the self-reporting option in the following circumstances:

- absence of a duration greater than 48 hours,
- assessments worth more than 30% of the student's final grade,
- if a student has already used the self-reporting portal twice during the academic year

If the conditions for a Self-Reported Absence (SRA) are *not* met, students will need to provide a Student Medical Certificate if the absence is medical, or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office to obtain more information about the relevant documentation.

Students should also note that individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds, or for other reasons. All documentation required for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.

You are expected to know what plagiarism is at this stage of your programme.

Turnitin <u>aids</u> in identifying plagiarism. All required papers will be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system.
