Biology 3436F/G or Psychology 3221F/G and either completion of at least 1.5 Biology courses from the 3000 level or above, or registration in year 4 of the Honours Specialization in Animal Behaviour.

Unless you have either the requisites for this course or written special permission from your faculty's Academic Counselling office to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

3. Course Description/Syllabus

A study of the relationships between animal behavior, ecology and evolution. Topics will include: evolution, optimization theory, survival strategies, game theory, reproductive strategies, and social behaviour.

Learning Outcomes

By the end of this course you should be able to:

- Recall and explain the discipline of behavioural ecology and how it relates to ecology, evolution, and behaviour.
- 2. Recall and explain the main behavioural ecology theories that are covered.
- 3. Critically evaluate text in the context of behavioural ecology theories.
- 4. Independently collect and synthesize information on a topic in the field of behavioural ecology.
- 5. Communicate scientific knowledge in written and oral forms.

Class structure

This is course is taught in a blended format. Online and asynchronous components include lecture and some lab content. In-person and synchronous components include weekly meetings, oral presentations, and some labs (after Jan 31). Topics are organized by week on Owl. Each week will have a variety of study materials, including content slides and activities.

Accommodated Evaluations

Late penalties (1% of course grade per 24 h) will accrue immediately after a deadline. Deadlines to complete the fact sheet, draft presentation, and draft essay will be subject to a 48 h grace period when accrued late penalties will not be deducted. For example, if you hand in your fact sheet 40 h after the deadline, a 2% late penalty will have accrued but this late penalty will not be applied. If you hand in your fact sheet 50 h after the deadline, a 3% late penalty will have accrued and this late penalty will be applied (i.e., the maximum grade you can achieve will be 2/5).

Academic Consideration for Student Absence

The following policy will apply only to the midterm. The makeup date for the midterm will be February 28, 9:30-10:30 am, NCB 293. If you miss the make-up midterm, your final exam will be worth 50% and your SimBio assignments will be worth 10%.

Students will have up to two (2) opportunities during the regular academic year to use an on-line portal to self-report an absence during the semester, provided the following conditions are met: the absence is no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are expected to contact their instructors within 24 hours of the end of the period of the self-reported absence, unless noted on the syllabus. Students are not able to use the self-reporting option in the following circumstances:

- for exams scheduled by the Office of the Registrar (e.g., December and April exams)
- absence of a duration greater than 48 hours,
- assessments worth more than 30% of the student's final grade,
- if a student has already used the self-reporting portal twice during the academic year

If the conditions for a Self-Reported Absence are *not* met, students will need to provide a Student Medical Certificate if the absence is medical, or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office to obtain more information about the relevant documentation.

Students should also note that individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds, or for other reasons. All documentation required for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.
