1. Course Information:

Biology 1290B – Biology and Microorganisms

The fundamental principles of biology with emphasis on cell function and the role of microorganisms in public health, sanitation, food, and nutrition. Restricted to Food and Nutrition modules or by permission of the Department of Biology.

Prerequisites:

Grade 12 U (4U) Biology

May not be taken for credit by students registered in any modules offered by either the Faculty of Science or the Schulich School of Medicine and Dentistry.

Course Objectives

- Identify and describe the function of the organelles and structures found in cells
- Compare and contrast eukaryotic and prokaryotic cells
- Understand the basic growth requirements of prokaryotes
- Be able to list the methods of controlling prokaryotic growth
- Be able to list the methods of controlling prokaryotic and eukaryotic pathogens in humans
- Describe the major groups of prokaryotic and eukaryotic pathogens and parasites describe the basic concepts of public health microbiology regarding municipal water purification and sewage treatment
- List other uses of microbes in Applied Microbiology

Assignments

Evaluation will be based on grades received on posted assignments. There will be approximately 10 assignments, and are due 1 week-later. Late penalties will apply. for late submissions. Assignments consist of short answer on topics either from the course or related to it. Each assignment will be worth the same all together adding up to 60%.

Academic Consideration for Student Absence

Students will have up to two (2) opportunities during the regular academic year to use an on-line portal to self-report an absence during the semester, provided the following conditions are met: the absence is no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are expected to contact their instructors within 24 hours of the end of the period of the self-reported absence, unless noted on the syllabus. Students are not able to use the self-reporting option in the following circumstances:

- for exams scheduled by the Office of the Registrar (e.g., December and April exams)
- absence of a duration greater than 48 hours
- assessments worth more than 30% of the student's final grade,
- if a student has already used the self-reporting portal twice during the academic year

If the conditions for a Self-Reported Absence are not met, students will need to provide a Student Medical Certificate if the absence is medical, or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office to obtain more information about the relevant documentation.

Students should also note that individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds, or for other reasons. All documentation required for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.
