3. Course Description, Learning Outcomes, Schedule, Delivery Mode

Description

The application of ecological principles to the management of wildlife species. Topics include: techniques, harvest, predation, habitat loss and management, stocking and reintroductions, and economics of wildlife. Identification and biology of game, pest, and furbearing species in laboratories; films are used frequently.

Learning Objectives

Further to the goals of the course listed below, outcomes for each lecture will be released with the lecture. By the end of this course, you should be able to:

- 1. Describe common ideas and challenges to the management and conservation of wildlife populations and offer solutions to those challenges.
- 2. Explain the methods used to study wildlife.
- 3. Be able to identify bird, mammal, amphibian, and reptile species that are native to Canada.

Mode of Delivery

Lectures will take place in-person during the scheduled class periods. Labs will also take place in-person during the assigned lab periods. You must attend your assigned lab section as you are not allowed to attend other lab sections without written approval from the course instructor. The material covered in lectures and labs are outlined in the following *Tentative Schedule*.

Contingency Plan

Although the intent is for this course to be delivered in person, should any university-declared emergency require some or all of the course to be delivered online, either synchronously or asynchronously, the course will adapt accordingly. Tentative Schedule

The lecture topics presented below are *tentative* and may change as the semester develops. I have invited guest speakers who may have to reschedule their talks. There will be periodic assigned readings in support of the lecture material posted periodically throughout the term. For those papers, you should make note of the purpose of the study and the major findings.

4. Course Materials

No textbook for the course is required, but a field guide is recommended. I personally like to have a physical copy because a well-organized field guide will put similar species close together, making it easier to perform an identification. The website allaboutbirds.org is an excellent resource for birds, available for free. iNaturalist.org is another good resource, and it covers a wide variety of species.

All course material (including required readings) will be posted to OWL (https://owl.uwo.ca); hence you should check OWL on a regular basis for news and updates. This is the primary method by which information will be disseminated to all students in the class. You are responsible for checking OWL on a regular basis. Your quiz grades will not be used in the calculation of your overall course grade; the quizzes serve as opportunities to practice your species ID skills in preparation for the lab midterm and final exam.	0%

Evaluation Content & Expectations

Lab evaluations may include bonus questions. The content of the bonus questions is meant to be a surprise, so there will not be any bonus questions on makeup tests. Unless a question on the midterm or final exam specifically says to include additional sources, answers will be marked based on information presented by the course instructor, guest lectures, any videos presented in class, and from assigned readings. Answers to all questions must be in your own words. That is, you may not copy-and-paste a lecture transcript and expect to receive full marks for a question.

6. Student Absences

Absences from Midterm and/or Lab Midterm

If you experienced an extenuating circumstance (illness, injury or other extenuating circumstance) sufficiently significant to temporarily render you unable to write the midterm, the lab midterm, and/or the lab final exam, you may submit a request for academic consideration through the Academic Counselling Office of your Faculty of Registration as soon as possible.

If you miss a Final Exam, please contact the Academic Counselling office of your Faculty of Registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a "Multiple Exam Situation" (e.g., more than 2 exams in 23-hour period, more than 3 exams in a 47-hour period). If you fail to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.
