A consideration of Horace's achievement as a lyric poet. Selected odes will be read closely with a view to language and style. Emphasis will be placed on Horace's engagement with both Archaic lyric and Alexandrian poetry, as well as on Horace's place in Roman literary and political history.

The bibliography on Horace is both rich and extensive. The recent commentaries are useful in assembling references to the most pertinent discussions of individual poems and problems. There are also substantial and useful bibliographies in S. Harrison (ed.), *The Cambridge Companion to Horace* (Cambridge 2007) and G. Davis (ed.), *A Companion to Horace* (Malden, MA 2010). The *Companions* are both excellent introductions to the poet, and are an obvious starting-point for research. See also M. Lowrie (ed.), *Horace: Odes and Epodes (Oxford Readings in Classical Studies*: Oxford 2009).
