Course Outline

Welcome and Course Description:

Welcome to CS 2902: Ancient Medicine!

This course will trace the development of ancient medicine from the earliest evidence of Egyptian and Mesopotamian medical practices, the development of Greek concepts of health and disease, through to the flourishing of Greco-Roman medicine at the height of the Roman Empire. Of particular interest to this course is the social dimension of ancient medicine, including questions of ethics, the social standing of medical practitioners (and their patients), and the role of women, both as healers, and patients. This course will also highlight the influence of ancient medicine on medical theories and practices during the Middle Ages, the Renaissance, and up to early modern times.

Course Objectives and Learning Outcomes:

Those who successfully complete this course will be able to do the following:

- Learn how to read and analyze ancient sources (in English)
- Learn about the development of theories of medicine in the Greco-Roman world
- Learn about the practice of medicine in antiquity and how it was affected by considerations of wealth, status, and gender

Students in this course will acquire the following skills:

- Be able to critically read source texts and extract relevant data from those texts
- Have an understanding of the major schools of medicine in the ancient world, including the origins of the Hippocratic Oath and its influence on modern notions of medical ethics and the medical profession in general
- Gain a substantial understanding of using primary evidence (archaeological, artistic, literary), including its potential and limits, in the reconstruction of ancient societies and their medical systems

Course Website:

All course content can be found on the OWL course site. Students are responsible to regularly check our OWL site for this class for reminders about upcoming quizzes/ tests, to read announcements, and to access class PowerPoints and other resources to prepare and review material for this course. Quizzes:

The quizzes test the primary source material covered in the preceding weeks, consisting of multiple choice and true/false questions, designed to test your comprehension of the primary sources and your ability to extract information from the excerpts given to you. There will be no proctoring. Quizzes will run on Fridays during the weeks indicated on the schedule below.

Tests and Final Exam:

There will be two tests, consisting of multiple-choice and true/false questions. The tests will focus on material (lectures and readings) covered in the weeks leading up to each test (Test #1: weeks 1-6; Test #2: weeks 7-12). Tests will be taken asynchronously on the "Tests & Quizzes" tab on OWL. The tests will **not be cumulative** and there will be no proctoring.

The final exam will be **scheduled by the registrar during the exam period**. The final exam will be **cumulative**, and consist of multiple-choice and true/false questions (based on lectures and readings). It will be timed (2 hours max.) and administered through OWL. No outside resources are permitted and it is considered an academic offence to use outside resources on this exam. NOTES TO STUDENTS:

- 1. Only on the documented basis of illness or other extreme circumstance will students be permitted to write a make-up test. It is the student's responsibility to ensure that they have a strong, stable internet connection for the completion of this course and the assessments.
