

# Earth Sciences 2240F Course Outline Catastrophic Events in Earth History Fall 2025

# 1. Course Information

Earth Sciences 2240F considers those events so dramatic and catastrophic that they leave evidence in the geologic record and can threaten life on Earth. Included will be violent volcanic eruptions, mega-earthquakes and tsunamis arising from them, rapid climatic changes and associated storms, and impacts from asteroids and comets. As much as possible, we will use the examples of recent events and processes to help interpret what we read in the rock record.

The content of the course incorporates definitions of basic geologic terminology and concepts required to proceed irrespective of background knowledge.

### Course Learning Objectives

- The primary goal of this course is to gain an understanding of those (predictable and unpredictable) events that catastrophically punctuate the normal evolution of Earth.
- We will learn what energy sources fuel Earth's processes in rocks, water and atmosphere, and what factors turn ordinary processes into extraordinary ones.
- We will learn the significance of geologic time and we'll learn how to read dates incorporated in ice, sediments and rocks.
- We will learn to write scientific reports; an assigned topic will be researched and presented in scientific format.

# 5. Methods of Evaluation

20% Mid-Term Examination

25% non-cumulative End-of-Term Examination

40% Scientific Report (2 assignment parts due Oct. 7 and Dec. 2 [course essay requirement])

15% nine Quizzes on course content

#### 20% Mid-Term (2 hour) written examination [online]

The Mid-Term Examination covers the first half of the course: Unit 1 and Unit 2 inclusive (to end of Chapter 9). Typically ~30 multiple choice questions, ~10 fill-in-the-blank questions and ~5 short answer questions.

#### Date and Time: Sunday, Oct. 19 2025 at 1pm

For online examinations, students are not permitted access to any additional materials.

The instructor must receive an academic consideration notification (either with or without supporting documentation) within 48 hours of the scheduled mid-term examination for the student to be permitted and scheduled to take the make-up mid-term exam. This is the mechanism to identify those students that need to write the make-up mid-term exam. See section 6.1 about submitting an academic consideration request.

### Make-up Mid-Term Examination [online] will occur on Saturday, Nov. 1 2025 at 1pm

Students that miss writing the make-up mid-term exam must submit an academic consideration request <u>with</u> supporting documentation within 48 hours of the scheduled make-up mid-term exam. The instructor has designated the make-up mid-term exam as the one assessment in this course that requires academic consideration <u>with</u> supporting documentation (again, see section 6.1).

Students that miss writing both the mid-term and the make-up mid-term (with supporting documentation) will write the mid-term the next time the course is offered (usually the next term).

## 25% End-of-Term (2 hour) written examination [online]

The End-of-Term examination is non-cumulative, covers the second half of the course: Unit 3 & Unit 4 inclusive (from Unit 3 Introduction to end of Chapter 20). Similar format as the mid-term exam.

#### Date and Time: To be determined by the Registrar's office

For online examinations, students are not permitted access to any additional materials.

Make-up End-of-Term Exam [online]: To be announced, determined by Registrar's office

You can only take the make-up End-of-Term ("special") Exam with permission from an academic counsellor.

If you miss the End-of-Term Exam, please contact the Academic Counselling office of your Faculty of Registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under Special Examinations), especially for those who miss multiple final exams within one examination period.

If a student fails to write a scheduled **Special Examination**, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred.

You may be eligible to write the Make-up End-of-Term Exam if you are in a "Multiple Exam Situation" (e.g., more than 2 exams in 23-hour period, more than

3 exams in a 47-hour period). Students who have any of these type of conflict(s) and who wish to explore alternative scheduling options, should submit an exam conflict through the <u>Student Absence Portal</u>.

## 40% <u>Scientific Report</u> (of an assigned research topic) Submitted in 2 Parts

- 10% Assignment 1 Draft of Introduction and Reference list, **Due Tues. Oct. 7** @ 1pm
- 30% Assignment 2 Final Scientific Report (2500 words), **Due Tues. Dec. 2 @ 1pm**

The assigned research topic and further detailed assignment information and instructions will be provided on the OWL course site.

This is an essay course, a passing grade on assignment 2's final scientific report (the 30%) is required to pass the course (see section 6.1). In other words, students <u>must submit</u> a final scientific report (not optional).

#### About Submission and Due Dates of Scientific Reports

- Reports are submitted as OWL "Assignments". It is best to upload your assignment reports in two formats: a MS Word document (to generate the Turnitin result) and a PDF (to preserve your report's formatting).
- When you submit an assignment you will receive an email receipt from OWL and an email receipt from Turnitin.com. **Keep these for your records.** 
  - Turnitin.com is the software that Western uses to check submitted work for plagiarism. This software compares your report to everything that has been published, everything on the internet, and all other student papers that have been previously submitted to Turnitin (from any university).
  - O Please Note: It can take several minutes, several hours or even a day for Turnitin to generate a report and you will not be allowed to resubmit an assignment while Turnitin is generating the report. Hence, you should not submit an unfinished draft close to the deadline in case your Turnitin result is delayed and you are not able to submit your final version before the deadline.
- The "**Due Dates**" recorded on the syllabus (and in the OWL Calendar) are the <u>final</u> dates of submission without penalty.
  - o No late penalty for reports submitted within the first hour after the deadline.
  - o Reports submitted within 1 4 hours after the deadline will receive a 2% penalty.
  - o Reports submitted within <u>24 hours</u> after the deadline will receive a 5% penalty.
  - On the 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> days after the **Due Date**, reports may be submitted but will be subject to a late mark deduction of 15%, 25%, or 35%, respectively. Each 'day' starts at the 1pm **Due Date** time (not midnight).
  - o No reports will be accepted 5 days after the **Due Date**. This means that on and after the 5<sup>th</sup> day after the **Due Date**, the assignment grade is a 0.
  - Extensions will not be granted because *you* have a time problem on the Due Date; it's up to *you* to manage your time and get the report assignments submitted. Meaning students should not submit an academic consideration request <u>without</u> documentation, it will be **denied**.
  - o If you require an extension for a legitimate medical or personal reason (e.g. physical illness or extreme stress), please get documentation from your doctor and take it to an academic counsellor in your home faculty to submit an academic consideration request with documentation.

15% Graded Quizzes (9 quizzes at intervals during the course; see Weekly Schedule above)

Graded quizzes may be attempted / submitted **at any time**. It makes sense to do them as you go, at the end of each chapter or section to which they apply. The quiz settings are set to **one attempt only** with unlimited time; Once submitted, the grade and incorrect questions (without answers) will be displayed/provided to you.

The date for students to complete all quizzes is three days prior to Fall term end, **Dec. 5 2025.** A three day grace period (plus a weekend) is provided to students to complete all quizzes without penalty by the last day of Fall term classes, **Dec. 9 2025**.

- Extensions will not be granted because *you* have a time problem on the Due Date; it's up to *you* to manage your time. Meaning students should not submit an academic consideration request without documentation, it will be **denied**.
- If you require an extension for a legitimate medical or personal reason (e.g. physical illness or extreme stress), please get documentation from your doctor and take it to an academic counsellor in your home faculty to submit an academic consideration request with documentation.

#### 6.1 Missed Coursework / Student Absences

All requests for Academic Consideration **must be made within 48 hours** after the assessment date or submission deadline.

All Academic Consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make <u>one</u> Academic Consideration request **without supporting documentation** in this course. However, the following assessments are excluded from this, and therefore always require formal supporting documentation:

- Make-up Mid-Term Examination (Designated by the instructor as the one assessment that always requires documentation when requesting Academic Consideration)
- Examinations scheduled during official examination periods (Defined by policy)

When a student <u>mistakenly</u> submits their <u>one</u> allowed Academic Consideration request **without supporting documentation** for the assessments listed above, <u>the request cannot be recalled and reapplied</u>. This privilege is forfeited.

### **6.2 Essential Learning Requirements**

Even when Academic Considerations are granted for missed coursework, the following are deemed essential to earn a passing grade.

• a passing grade on essays or lab reports (i.e., assignment #2's full scientific report) in a course designated as an "essay course" (i.e., with a suffix of E, F, G, or Z) to satisfy the Senate requirement that students must demonstrate "some minimal competence in essay writing" in order to pass the course.

The consequence of not meeting the above requirement (a grade of 49 or lower on assignment 2's full scientific report) is the student would not pass (would fail) the course.

#### **6.3** Use of Generative AI Tools

The use of generative AI tools (e.g., ChatGPT, Microsoft Copilot, Google Gemini, or similar platforms) is **not permitted** in the completion of any course assessments, including but not limited to: assignments, scientific reports, quizzes, and final examinations.

Using such tools for content generation, report writing, problem solving, translation, or summarization—when not explicitly allowed—will be treated as a **scholastic offence**.

If the use of generative AI is permitted for a particular assessment, the conditions of use will be specified by the instructor in advance. If no such permission is granted, students must assume that use is prohibited. It is your responsibility to seek clarification before using any AI tools in academic work.

## 6.4 Religious Accommodation
