# 3. Course Syllabus, Schedule, Delivery Mode

<u>Description</u>: An exploration of the issues facing the world's fresh water supply. Emphasis will be on major problems in the water arena (e.g., droughts, floods, pollution, population shifts & growth, region specific climate change, conflict, water rights and allocations).

### **Learning Outcomes**

Upon successful completion of this course students will be able to:

- Understand all components of the global hydrologic cycle including precipitation, evapotranspiration, surface water flow, unsaturated zone flow, and ground water flow.
- Understand, and be able to communicate to others, how fresh water is infinitely recyclable, how it is global in scale, and critical shortages or flooding are local in scale.
- View the science of the water cycle in the social context of global usages.
- Make better informed decisions on how we, in a global and local context, use our water in a sustainable manner.
- Improve presentation skills.

## \*Tests

- All tests will be 'closed book'. All work must be done independently. Not adhering to these conditions will be considered a scholastic offence. - Tests no aids permitted (pen or pencil only). Cell phones must remain on 'silent' and in bags / backpacks.
- Tests are to be written and will be graded in essay format. Each test will consist of 3 questions taken from a question sheet that will be provided to you at least 1 week prior to the test. Each test is assumed to contain approximately 500 words. Thus, the tests count towards 1000 words of the essay course requirement of 2500 words (minimum).
- You will be provided with a list of possible questions approximately 1 week ahead of the test. You should also use the washroom prior to the test as the ability to take breaks will be very limited (i.e. emergency only). As per university policy GTA's must accompany students to the washroom which will necessitate only one student leaving the room at a time. This is one reason the tests are kept as short as possible.

- You are strongly encouraged to attend all lectures and take notes. Tests focus on material discussed in class within certain contexts. If you miss lectures you will not understand how to answer the test questions properly.
- All work must be done independently. Not adhering to these conditions will be considered a scholastic offence. ## **Major Paper**

- Major Paper 1 is to be between 1000 and 1250 words. Major Paper 2 is to be between 500 and 750 words.
   Word counts, excluding references, are to be noted after the title. More details will follow on topics and format.
- Any assignments handed in past the due date will be subject to a penalty of 20% per late day (if you have exceptional circumstances contact the instructor *schincar@uwo.ca* prior to due date).
- In order to pass the course a passing grade on the Major Papers must be achieved.

#### **Group Presentations**

- While the group is evaluated for the grading individual members may receive a higher or lower grade than 'the group'. Group presentations are such that each member of the group will be responsible for a given component of the water budget. As such each group member will present their work on this component as part of the overall group presentation. This will allow for adjustments to individual grading should certain member perform well above or below the group average.
- All group presentations are due by noon Nov. 24 via Owl submitted as a 'ppt show'. Late submissions will receive a 20% per day penalty.

Generative AI Tools (ChatGPT, Copilot, Gemini) are prohibited in this course.
