# Seminar in Restoration and Eighteenth-Century Literature: Poetry and the Body English 4340G (001) Winter 2022

# **Course Description**

In this course, we will read this poetry as an inquiry into the role of embodiment in the poetry of the eighteenth century. During the eighteenth century big questions about how the body relates to the mind and soul were debated and remained unresolved. Our course will discuss those questions as they are articulated in poetic forms and language. We will especially from groups traditionally marginalized in British literary history: women and people of colour to gauge their view of the body. We will also look at the important roles of nonhumans in this poetry.

NOTE: This course will include an intensive focus on research methods and writing research essays. We will have at least one class in Weldon's Archives and Special Collections.

# Objectives:

By the end of the course, successful students will have:

- advanced understanding and deployment of the language of literary analysis
- advanced facility with a variety of approaches, theories and techniques which can be applied to the study of literature
- basic ability to articulate their own skill set
- advanced understanding of race and gender in literary history
- advanced proficiency with the essential tools of literary scholarship (library catalogues, citation and content databases) and the more specialized tools of several different fields (Iter, ECCO, etc.)
- basic understanding several highly specialized research tools and their uses (such as variorum editions, published bibliographies, concordances, etc.)
- advanced ability to critique and review secondary sources within the context of their scholarly tradition

### Methods of Evaluation

The grade for the course will be arrived at as follows:

2 or 3 shorter research assignments as preparation for a research essay 12-14 page research essay Class participation

# **Academic Consideration for Student Absence**

Students will have up to two (2) opportunities during the regular academic year to use an on-line portal to self-report an absence during the term, provided the following conditions are met: the absence is no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are expected to contact their instructors within 24 hours of the end of the period of the self-reported absence, unless noted on the syllabus. Students are not able to use the self-reporting option in the following circumstances:

- for exams scheduled by the Office of the Registrar (e.g., December and April exams)
- absence of a duration greater than 48 hours,
- assessments worth more than 30% of the student's final grade,
- if a student has already used the self-reporting portal twice during the academic year

If the conditions for a Self-Reported Absence are *not* met, students will need to provide a Student Medical Certificate if the absence is medical, or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office to obtain more information about the relevant documentation.

Students should also note that individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds, or for other reasons. All documentation required for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.

Whenever students take an idea or passage from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing such as footnotes or citations. Plagiarism is a major academic offence.

# Plagiarism Checking:

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com <a href="http://www.turnitin.com">http://www.turnitin.com</a>.

All instances of plagiarism will be reported to the Chair of Undergraduate Studies. Proven cases of plagiarism will result in a grade of zero for the assignment. Subsequent offences will result in failure for the course.
