# The Storyteller's Art II | Introduction to Narrative: Funny Stuff-Comedy and the Comedic Form in Literature (and Elsewhere)

# **Course Description**

This half-course looks at comedy as a literary genre. Often perceived as an inferior mode of writing (as it is in Aristotle's <u>Poetics</u>), comedy has a rich history that covers everything from slapstick to the sophisticated musings of Noel Coward. We will look at comedy and comedic work in several forms (literary and cinematic) and consider the nature of comedy: what is funny? and does comedy have to be funny? what satisfies? what does comedy offer the contemporary audience? Students will be expected to read a number of texts (novels, stories, plays, and some theoretical material) and to view prescribed films (not screened in class) in order to discover the varied richness of comedic forms such as parody, farce, satire, and romance.

## Objectives:

- Throughout the course, successful students will develop their ability to read and think critically.
- Through tests and assignments, students will improve their writing skills.
- Students will develop their knowledge of comic forms and conventions.
- Students will apply this knowledge in their written work.
- Students will encounter a range of texts from "classic" to contemporary that will allow them to gain some measure of the background for future literature courses.

## Methods of Evaluation

In addition to a final examination in April (35%), there will be two essays (10% and 25%) due during the term. As well there will be a mid-term test (20%), and a tutorial grade (10%)

## **Academic Consideration**

  - a. Self-attestation signed by the student;
  - b. Indication of the course(s) and assessment(s) relevant to the request;
  - c. Supporting documentation as relevant.

Requests without supporting documentation are **limited to one per term per course**.

Instructors may designate one assignment or assessment as exempt from this allowance. In this course, requests for academic consideration pertaining to the term test **must** be accompanied by supporting documentation.

Assignments with flexible deadlines and any term work that does not count towards the course grade are **not** eligible for additional consideration.

Documentation for medical illness, when required, includes the completion of a <u>Western Student Medical Certificate (SMC)</u> or, where that is not possible, equivalent documentation, by a health care practitioner.

Requests linked to examinations scheduled by the Office of the Registrar during official examination periods as well as practice laboratory and performance tests typically scheduled in the last week of term **always** require formal supporting documentation.

#### **Attendance**

Attendance is mandatory in all classes and tutorials. In cases of excessive absenteeism (e.g. more than 9 unexcused hours for a half course, 18 for a full course), which are not accounted for by either academic consideration or accommodation, students may be debarred from taking the final examination, and will receive an official warning to this effect by or before the course

drop date (see Senate policy). In classes with or without final exams, students who do not attend class will receive 0% for course participation grades. Unless other policies dictate a different set of penalties in specific English and Writing Studies programs, this will apply to all department programs.
