#### **OLD AND MIDDLE ENGLISH**

In order to develop a wide-ranging competency to teach and research in the field of Old and Middle English, candidates will prepare a reading list according to the instructions and requirements below.

#### 1. Instructions

## i. Secondary Field Exam

Students will read all the material listed as the CORE material. Students are expected to read the material in the original.

# ii. Primary Field Exam

Students will read all the material listed as the CORE material and one of the optional sections. Those specializing in Old English will read the material listed separately below as the Primary Field material for Old English. Those specializing in Middle English will read approximately half of the material listed below as Primary Field material for Middle English. Students are expected to read the material in the original.

#### 2. Exam Structure

The examination will have three questions: the first question will offer you two passages, one from Old English and one from Middle English, and ask you to discuss one of them offering a close analysis of its linguistic and stylistic features, and its interpretation. The second question will address Old English texts, and the third will consider Middle English texts.
