**TEXTUAL STUDIES**

In order to develop a wide-ranging competency to teach and research in the field of Textual Studies, candidates will prepare a reading list according to the instructions and requirements below.

**1. Instructions**

**i. Secondary Field Exam**

Candidates are required to read all of Part A, and to make choices in Parts B, C, and D. These choices should be submitted to the examining committee for approval by July 1 for the September exams and November 1 for the January exams. Please see specific instructions regarding additional selections under each part.

**ii. Primary Field Exam**

This qualifying examination is only offered as a secondary field.

**2. Exam Structure**

- i. Answer three questions, one from each part.
- ii. All questions are of equal value.
- iii. Do not write extensively on the same writer in more than one question.
- iv. Do not repeat material in different questions, and choose your questions to reflect a range of topics and problems.
- v. Over the course of the examination you should write extensively (the focus of one-third of one question) at least once on each of these four historical periods: oral and manuscript culture (Classical and medieval), early print culture (Renaissance, 17th and 18th centuries), later print culture (19th, 20th, and early 21st centuries), digital culture (late 20th and early 21st centuries).
- vi. Support your answer to each question with specific reference to relevant texts.
