

The Department of Civil & Environmental Engineering (CEE) and the John M. Thompson Centre (TC) for Engineering Leadership and Innovation at Western University invite applications for a Teaching Scholar (TS) joint appointment between the CEE Department and TC at the rank of Assistant or Associate Professor with appointment to be commensurate with experience. TS appointments at the rank of Assistant Professor will lead to consideration of continuing status and promotion to Associate Professor, at the end of the probationary period (normally 6 years). TS appointments at the rank of Associate Professor will lead to consideration of continuing status at the end of the probationary period (normally 3 years). The position will begin July 1, 2024. The successful candidate will teach a total of five half courses per academic year at the CEE Department and the TC, will carry out assigned duties related to committee and other service within the CEE Department and the TC, and will engage in scholarship to broaden and deepen the Scholar's pedagogical expertise and/or contribute to the pedagogical development of the CEE department and the TC. Scholarship activities may include (but are not limited to) curriculum development and evaluation, presentations and publications on teaching or pedagogy, research into the efficacy of various pedagogical approaches, educational leadership, or other research on pedagogy. Teaching is the primary academic responsibility of a TS but alternative arrangements can be made according to the CEE Department and TC needs in teaching and service.

The successful candidate should hold Bachelor and PhD degrees (or equivalents) in Civil Engineering; provide evidence of strong classroom teaching abilities in engineering and applied science. The ability to become eligible for registration as a Professional Engineer in Ontario is required for this appointment. The candidate is expected to be committed to the Equity, Diversity, and Inclusion (EDI) principles.

The successful candidate will teach primarily in the undergraduate CEE and TC programs, instructing students in classroom, laboratory, and studio environments in fundamental and applied engineering courses. The successful candidate may also be required to teach courses in the professional Master's (M.Eng.) programs in CEE and TC.

Eligibility: Only current members of the University of Western Ontario Faculty Association (UWOFA) holding a Limited Duties or Limited Term position or former Members who held a Limited Duties or Limited Term appointment at the time of ratification of the current Collective Agreement (23 November 2018) are eligible to apply.
