Position Profile: A Full-time Limited Term Clinical Academic appointment at the rank of Assistant Professor or Associate Professor, or a Continuing Clinical Academic appointment at the rank of Associate Professor or Full Professor, depending upon experience and qualifications at the time of appointment.

Division Profiles: The Department of Obstetrics and Gynaecology has 36 full-time academic physicians, 3 basic scientists, 32 postgraduate residents, and 10 fellows and opportunities exist for clinical and basic science research. The MFM Division provides comprehensive care to women with fetal and maternal complications of pregnancy and consultation support to London Health Sciences Centre and the Southwest region of Ontario.

Academic and Clinical Expectations: The successful candidate will work within the Division Maternal Fetal Medicine. The MFM division provides preconceptual counselling, antenatal and intrapartum care for women with medical and obstetrical complications of pregnancy. Prenatal diagnosis, obstetrical ultrasound, and assessment and management of fetal anomalies are managed in collaboration with genetics, radiology, neonatology and paediatric subspecialties. Special clinical and research interests within the group are management of obesity in pregnancy, abnormal placentation, first trimester sonography, utilization of MRI in pregnancy and obstetrical triage. The successful candidate must be interested in pursuing a strong academic career and will be expected to participate actively in the Divisions academic, research, and education initiatives including teaching and supervision of undergraduate students, postgraduate trainees, and fellows. The candidate will be responsible and share equitable coverage for city-wide Obstetrics & Gynaecology call. The successful candidate must be interested in pursuing a strong academic career and have a proven track record of productivity consistent with their level of training and years of experience.

Qualifications: The successful Candidates must hold an MD and be eligible for licensing in the Province of Ontario. Specialist certification in Obstetrics and Gynaecology through the Royal College of Physicians and Surgeons of Canada or equivalent is required, and a formal fellowship in Maternal-Fetal Medicine. The successful candidate will have a commitment to and demonstrated aptitude for teaching and will be expected to teach at the undergraduate and graduate levels and to supervise graduate trainees. The successful candidate must demonstrate excellence in teaching, research, publication, and collaboration within multidisciplinary teams.

Compensation Details: Compensation for this position will be commensurate with qualifications and experience and will be primarily composed of the following sources: Fee for service (OHIP billings), Alternative Funding Plan, academic salary, workers safety insurance board, and on-call reimbursement.
