



LIMITED-TERM APPOINTMENT IN CRIMINAL, ADMINISTRATIVE and/or CONSTITUTIONAL LAW

Applicants must have a JD, LLB, or equivalent degree, as well as a relevant graduate degree or its equivalent, which may include a record of successful legal practice. Teaching experience is also an asset.

Successful candidates will be expected to teach several courses in the JD program and actively participate in the mentorship of students and in the academic life of the Faculty of Law.
