

Tier 2 Canada Research Chair in Public Health Economics Schulich School of Medicine & Dentistry Western University



The Schulich School of Medicine & Dentistry at Western University, one of Canada's leading research-intensive universities, is seeking applicants for a Tier 2 Canada Research Chair (CRC) in Public Health Economics. In accordance with the regulations set for Tier 2 Canada Research Chairs (http://www.chairs-chaires.gc.ca/home-accueil-eng.aspx), the candidate will be an excellent emerging researcher who has demonstrated research creativity and innovation with a track record of publication in leading peer-reviewed journals, and the potential to achieve international recognition in the fields of Public Health Economics. The CRC position is for a five-year period, with the possibility of renewal for one additional term.

Tier 2 Chairs are intended for exceptional emerging scholars (i.e., candidates must have less than 10 years of experience as an active researcher in their field at the time of nomination). Applicants who are more than 10 years from having earned their highest degree (and where career breaks exist, such as maternity, parental or extended sick leave, clinical training, etc.) may have their eligibility for a Tier 2 Chair assessed through the program's Tier 2 justification process, please contact Research Development Western for more information.

Public health is a vital component of a country's health care system, and training public health practitioners is a core function of a University. Western's new Schulich Interfaculty Program in Public Health adopts an innovative approach to educating tomorrow's public health professionals - an interfaculty approach that uses the case based and experiential method of learning. This is among the first programs in the world to adopt this training method for public health. The Centre for Medical Evidence, Decision Integrity & Clinical Impact (MEDICI) is a World Health Organization (WHO) Collaborating Centre focused on evidence-based healthcare decision-making.

The Tier 2 CRC will be expected to establish an independent, externally funded, research program. The ideal candidate will be a health economist or health services researcher who evaluates public health interventions/technologies/ programs from an equity, efficiency and effectiveness perspective. Applications from candidates whose work can inform the work of other programs within the Interfaculty Program in Public Health or MEDICI are strongly encouraged to apply. Candidates must propose an innovative research program of high quality that would attract excellent trainees, students and future researchers. The individual will have excellent opportunities to collaborate with other faculty within the Schulich School of Medicine & Dentistry and at Western, which includes health economists, health services researchers, experts in health promotion, health management and health law, epidemiologists, and anthropologists. The successful candidate will further our goal of developing an exceptionally strong and cutting edge case based public health training and research program.

Western recognizes the potential impact that legitimate career interruptions can have on a candidate's record of research achievement. Potential candidates are encouraged to explain within their application the impact that career interruptions have had on their record, and to submit a full career or extended CV to a chairholder position in cases where they have had career interruptions.

A successful candidate holding a PhD in a relevant field will be appointed to a Probationary (tenure-track) appointment at the rank of Assistant Professor or Associate Professor, or to a tenured appointment at the rank of Associate Professor, depending on qualifications and experience, in the Department of Epidemiology & Biostatistics and/or appropriate Departments at the Schulich School of Medicine & Dentistry. Depending on the candidate's qualifications, cross appointments are possible with the Faculty of Science, Faculty of Health Sciences or the Ivey Business School. Compensation for this position will be commensurate with qualifications and experience.

Western University is located in London, Ontario, with a metropolitan census of 530,000. London boasts an extensive educational and health care community including two large teaching hospitals with multiple sites, two research institutes, an Institute for Clinical Evaluative Sciences node, and the Southwestern Academic Health Sciences Network.
