Letter of Information

The Western Equity Census collects equity, diversity, inclusion, and decolonization (EDI-D) demographic data from members of the Western community.

The data will help Western fulfill its commitments to equity, diversity, inclusion, and decolonization, by using responsible collection and analysis of personal information and data that accurately reflects the demographic composition of Western's community. The data will help to inform decisions related to organizational strategies, policies, and planning.

Question areas include: Indigenous Identity; Racial Identity; Accessibility; Sexual Orientation; Gender Identity; Educational Attainment; Socio-Economic Status; and Sense of Belonging. Questions were created in consultation with the EDI-D Demographic Data Collection Group and members of the Western community.

Answers to these questions will help Western monitor and respond to EDI-D related trends and issues, and to report publicly on progress towards EDI-D goals. The data collected through the Western Equity Census will be used in a culturally safe, ethical, purposeful, useful, transparent, and accountable way. This information is being collected for the purposes of quality assurance and quality improvement. While the census itself is not anonymous, the data will always be reported in aggregate form only to maintain the anonymity of respondents.
