Calendar Course Description (including prerequisites/anti-requisites):

Intimate relationships, like those found between marital or dating partners, are examined from a social science perspective, looking at love, mate selection, attachment, loneliness, conflict, relationship dissolution, and factors contributing to successful long-term relationships. Other

close relationships also are considered, such as those between friends or parents and children. Extra Information: 3 lecture hours.

- 1. There are no guizzes in this course. Students will write 2 tests.
- 2. Test 2 is considered central to the assessment of learning outcomes in this course. Accordingly, students must provide documentation for any absence from this evaluation. If you miss Test 2, you must complete the makeup assessment as follows: discuss potential make-up date with the instructor and write the make-up. The makeup assessment is an extension of the Test, and so you will need to present documentation for this assessment, should you need to miss it. Information about late or missed assessments:

Course-specific conditions:

All components of the course must be successfully completed to pass the course.

Absence from Course Commitments

Please note that any academic considerations granted in this course will be determined by the instructor of this course, in consultation with the academic advisors in your Faculty of Registration, in accordance with information presented in this course syllabus. Appealing a Grade Within this Course

You have the right to appeal any grade within this course. Appeals generally proceed in this order:
