# **Course Description:**

A study of nutritional requirements from conception to senescence. Discussion of food habits and nutrition intervention programs in relation to the stages of the lifecycle. Prerequisite(s): Foods and Nutrition 1070A/B or Foods and Nutrition 2070A/B or the former Foods and Nutrition 1030E or the former Foods and Nutrition 2121.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

- 4. Understand the factors that determine nutritional needs and the utilization of foods throughout the lifecycle.
- 5. Recommend practical food choices appropriate for different age groups, taking into consideration the influence of the psychological, political, social, cultural, and economic factors on food consumption.
- 6. Be aware of the main credible sources of public health nutrition information and

#### Notes:

- 1. This course has 6 quizzes. The 4 quizzes with the highest marks will be counted towards your final grade. Academic consideration requests will be denied for the first 2 missed quizzes. Academic Consideration requests may be granted when students miss more than 2 quizzes. These additional missed quizzes will be equally reweighed if academic consideration is approved.
- 2. This course (through MindTap) has Knowledge Checks (KC) at the beginning of each chapter. They are to be completed at the beginning of each module. Students who complete the KCs from the first 6 modules will receive the full 10%. Students who complete less than 6 will receive 0.
