Calendar Course Description (including prerequisites/anti-requisites):

An integrative study of physical activity and its impact on health and performance. This course will emphasize the role of nutrition to support health, fitness and performance goals in a variety of populations and explore current trends in sport nutrition.

Restricted to students in Foods and Nutrition and Families and Nutrition modules.

Prerequisite(s): Foods and Nutrition 1070A/B, Foods and Nutrition 1241A/B, Physiology 1021 or Physiology 2130, and Biochemistry 2280A or Biochemistry 2288A.

Antirequisite(s): Foods and Nutrition 3339A/B, Kinesiology 3339A/B.

My Course Description

This course is designed to provide students with an overview of the role nutrition professionals play in supporting physical activity among a variety of populations and focuses on the nutritional strategies that support athletes at all levels during all stages of training and performance.

- 5. Develop knowledge translation skills by developing educational materials for athletes

Please note that any academic considerations granted in this course will be determined by the instructor of this course, in consultation with the academic advisors in your Faculty of Registration, in accordance with information presented in this course syllabus. Appealing a Grade Within this Course

You have the right to appeal any grade within this course. Appeals generally proceed in this order:

- 1. Course instructor (informal consultation)
- 2. Department Chair (submission of written request)

In the case of perceived procedural unfairness, steps 2 and 3 are carried out within the Department and Faculty offering the course.
