3. Know the basic elements of different of methodological approaches and understand their merits and limitations.

5. Understand the ethical considerations involved in doing human subjects research.
6. Develop skills for reading and critically thinking about empirical social research.

### Notes:

1. This assessment has been designated as being central to the evaluation of learning outcomes in this course. Accordingly, you must provide documentation for any absence from this evaluation. If you miss this evaluation, you must complete the makeup assessment. The makeup assessment is an extension of the Midterm Test, so you will need to present documentation for this assessment, should you need to miss it. Please note that there is only one makeup assessment for this Midterm. Students approved to miss the makeup will have the weight of this assessment transferred to the final exam. Students must not provide medical or compassionate documentation to the instructor.
2. You must submit this assignment by the deadline listed. Should extenuating circumstances arise, you are permitted to submit your assignment up to 72 hours past the deadline without a late penalty. No Academic Consideration is required for this extension. Students submitting their assessment beyond the extended deadline will receive a penalty of 5% per day that it is late. ### **Midterm Exam (30%) – October 2**

This online midterm exam will cover the materials from Sept 8 to Sept 28. It will consist of multiple-choice questions only. Requirements of this exam include memorization of facts and definitions and application of information from the reading and lectures. To ease your exam preparation, I will only test you on the materials from lectures. This exam will be available from 8:00am until 11:59pm. If you miss the exam, you must have academic accommodation in order to have a makeup exam.

### **Two Online Posts (20%, 10% each) – October 9 & November 13**

This assignment is designed to help you apply key concepts from research methods to real-world examples, while also engaging with your peers in scholarly discussion. You will first share your view in discussion forum on Brightspace and respond to **two** other students' posts in a scholarly manner. The detailed instruction will be posted on Brightspace. The first post is due on October 9, 11:59pm and the second post is due on November 13, 11:59pm.

### **Group Research Proposal (15%) – December 9**

Throughout this semester, you will be working closely with your group members to develop a research proposal. You will first develop a research topic and complete required components, such as research question, hypothesis, a causal model, conceptualization, operationalization, sampling, study design and literature review. The detailed instruction will be posted on Brightspace. This group assignment is due on Tuesday, December 9 by 5:00pm.

### **Group Presentation (10%) – November 24 & December 1**

Before the submission of the group research proposal, every group will present the proposal in class. Please note that your group can present the “work in progress”, meaning that you do not need to complete the proposal before the presentation. Instead, your group will highlight every part of your research topic instead of providing full details of your proposal. The date of your group presentation will be determined in advance.

### **Final Exam (30%) – During December Exam Period**

This final exam will cover all the materials you have learned in this course. It will consist of multiple-choice questions only. However, more questions will come from the materials covered after the midterm exam. Requirements of this test include memorization of facts and definitions and application of information from the reading and lectures. To ease your exam preparation, I will only test you on the materials from lectures. If you miss the exam, you must have academic accommodation in order to have a makeup exam. The exam delivery format will be announced by the end of the semester.

### **General information about assessments**

- All assignments are due at 23:59 EST unless otherwise specified.
- You are responsible for ensuring that the correct file version is uploaded; incorrect submissions including corrupt files could be subject to late penalties (see below) or a 0.
- Written assignments will be submitted to Turnitin (statement in policies below).
- You will have access to Turnitin reports before your submission is graded.
- After an assessment is returned, you should wait 24 hours to digest feedback before contacting their teaching assistant; to ensure a timely response, reach out within 7 days.
- Prior to the filing of a written request for relief, you should attempt to resolve the concern regarding a mark or grade through informal consultation with the instructor. ### **Rounding of Grades** (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or 'giving away' of marks. Please don't ask me to do this for you; the response will be "please review the course outline where this is presented".

### **Information about late or missed assessments:**

- Late assessments submitted without approved academic consideration will incur a penalty of 5% per day, or may receive a grade of zero if excessively overdue
- If you miss the midterm exam and require a makeup exam, you will need to be approved by the academic advisor in order to write the makeup exam. The date will be set by the instructor.

### **Course-specific conditions:**

- You must complete all the required assessments in order to pass this course.
