## **Calendar Course Description (including prerequisites/anti-requisites):**

Covers principles of sensory and consumer science including test methods (discrimination, affective and descriptive tests), questionnaire design, experimental design, statistical considerations, and decision analysis. Examines sensory properties of foods through lab experiments and projects.

### **My Course Description**

This course covers the principles and practices of sensory and consumer science as applied to food products. Students will explore the foundational methods used to assess sensory characteristics, including discrimination testing, affective (consumer) testing, and descriptive analysis. Emphasis will be placed on the design and implementation of sensory studies, including questionnaire development, experimental design, and key statistical approaches for data analysis and interpretation. Students will also learn how to integrate sensory data into decision-making processes in product development and quality control contexts. Through hands-on laboratory experiments, students will evaluate the sensory properties of foods, apply testing protocols, and analyze results to draw meaningful conclusions. The course fosters critical thinking and practical skills essential for careers in food science, product development, market research, and quality assurance.

### **Learning Outcomes**

Upon successful completion of this course, you will be able to:

1. Acquire knowledge of the fundamentals of sensory and objective evaluation of food.
2. Apply this knowledge to food evaluation in the lab.
3. Recognize the principles involved in selecting appropriate sensory methods for specific projects.
4. Research, design, and complete an independent research project on food evaluation.
5. Demonstrate acquired knowledge through the midterm and final exams.
6. Respect the ethics as applies to conducting a sensory panel.
7. Develop critical thinking, teamwork, and oral communication skills.

#### **Information about late or missed assessments:**

- Students are expected to submit this assignment by the deadline listed. #### **Course-specific conditions:**

- Students must attend in-person laboratories and cannot miss more than (1) lab experiment without accommodation.
- Laboratory activities provide diverse hands-on experiences and expose students to learning about and working with different foods, which prepares them to work in any food and nutrition field. During food labs, students are required to prepare, process, store, and dispose of any type of food product, including **dairy, eggs, meat, fish, and poultry**, according to safe-food-handling principles and regulations. Further, students are required to clean and sanitize, according to regulations and best practices, all pots, dishware, utensils, and surfaces that have come in contact with **all food products**. Personal beliefs and practices that conflict with these course requirements are **not** grounds for academic accommodation.
- Students in accredited Food and Nutrition programs are expected to meet the Practice Competencies in the Integrated Competencies for Dietetic Education and Practice and/or the Competencies of the Canadian Society of Nutrition Management. Students must demonstrate, prior to graduation, that they can perform the required tasks. For example, students must demonstrate food preparation techniques and participate in the storage and disposal of food. This ensures that graduates will be able to meet the dietary needs of others, provide client-centered care, and effectively and safely manage food service operations.

**INC (Incomplete Standing):** If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

**SPC (Special examination):** If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned.
