#### Calendar Course Description (including prerequisites/anti-requisites):

Advanced principles and practices of medical nutrition therapy and nutritional support. Metabolic, anatomical and physiological alternations in selected diseases are the basis for the nutritional care plan.

**Prerequisite(s):** Biochemistry 2288A or Biochemistry 2280A, Foods and Nutrition 3351A/B. Registration in the Honors Specialization in Nutrition and Dietetics module.

\*Students who enrolled in the Honours Specialization in Nutrition and Dietetics prior to fall 2019 will be able to complete the module with the previous modular requirements and pre-requisites listed: Biochemistry 2280a or 2288a, and Foods and Nutrition 3351a. Registration restricted to students in the Foods and Nutrition Programs.

6. Develop critical thinking, collaborative teamwork and oral communication skills to optimize patient-centered care.

8. To advocate and act as each patients' nutrition ombudsperson related to nutrition and health.
9. Practice within the context of Canadian diversity and in a manner which provides cultural safety.

### **\*ICDEP: Integrated Competencies for Dietetic Education and Practice**

#### **ICDEP Competencies**

ICDEP Competencies (Specific to the Brescia School of Food and Nutritional Sciences, Honors Specialization in Nutrition and Dietetics)

As an accredited dietetic program in Canada, we are required to meet the ICDEP Competencies. Within these competencies, there are 7 inter-related Domains (areas) of Practice Competencies: Food and Nutrition Expertise, Professionalism and Ethics, Communication and Collaboration, Management and Leadership, Nutrition Care, Population Health Promotion, and Food Provision. This course was designed to ensure that students who complete the course as outlined obtain certain competencies in the above domains, which is necessary to meet entry level practice.

## Notes:

1. Midterm: this assessment is considered central to the assessment of learning outcomes in this course. Accordingly, students must provide documentation for any absence from this evaluation. If you miss this evaluation, you must complete the makeup assessment as follows: a make-up test will be scheduled within 1 week of the original assessment date. The makeup assessment is an extension of the Midterm Test, and so you will need to present documentation for this assessment, should you need to miss it. Please note that there is only one makeup assessment for this Midterm. Students must not provide medical or compassionate documentation to the instructor.
2. Students are expected to submit this assignment by the deadline listed. Should extenuating circumstances arise, students are permitted to submit their assignment up to 72 hours past the deadline without a late penalty. No Academic Consideration is required for this extension. Students submitting their assessment beyond the extended deadline will receive a penalty of 1% per hour that it is late. Academic Consideration requests may be granted only for extenuating circumstances that began before the deadline and lasted longer than the extension. **Students must not provide** medical or compassionate documentation to the instructor.
3. You cannot use undocumented absences for final exams.

## General information about assessments

- All assignments are due at 23:59 EST unless otherwise specified.
- Students are responsible for ensuring that the correct file version is uploaded; incorrect submissions including corrupt files could be subject to late penalties (see below) or a 0.
- A student might not receive** the same grade as their group members if it is determined that the distribution of work was not equal.
- After an assessment is returned, students should wait 24 hours to digest feedback before contacting their evaluator; to ensure a timely response, reach out within 7 days.
- Prior to the filing of a written request for relief, students must attempt to resolve the concern regarding a mark or grade through informal consultation with the instructor. If the student is dissatisfied with the decision of the instructor or does not receive a decision from the instructor, a written request for relief must be submitted to the Undergraduate Chair of the School offering this course, within three (3) weeks from the date that the mark was issued.

## **Rounding of Grades** (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or 'giving away' of marks. Please don't ask me to do this for you; the response will be "please review the course outline where this is presented".

### **Information about late or missed assessments:**

- Late assessments without academic consideration will be subject to a late penalty of 1% per hour
- One makeup exam will be available 1 week following the midterm, during regularly scheduled class time.

### **Course-specific conditions:**

- If you fail the final exam, you will receive a failing grade in the course.

**INC (Incomplete Standing):** If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. **SPC (Special examination):** If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned.
