Calendar Course Description (including prerequisites/anti-requisites):

An integrative study of nutrition at the intermediate level. This course explores the roles and functions of nutrients at the organ and system levels under various physiological conditions.

Prerequisite(s): Foods and Nutrition 1070A/B or Foods and Nutrition 2070A/B; Foods and Nutrition 1241A/B or Foods and Nutrition 2241A/B; Physiology 1021 or Physiology 2130.

Corequisite(s): Biochemistry 2288A or Biochemistry 2280A.

Notes:

1. Designated Assessment: Midterm. This assessment has been designated as being central to the evaluation of learning outcomes in this course. Accordingly, students must provide documentation for any absence from this evaluation. Please note that there is only one makeup assessment for this Midterm, schedule two weeks later during class time. Students must not provide medical or compassionate documentation to the instructor. Students who do NOT write the midterm or the makeup midterm will write a 4- hour cumulative final exam
2. Students are expected to submit their assignments by the deadline listed. Should extenuating circumstances arise, students are permitted to submit their assignment up to 72 hours past the deadline without a late penalty. No Academic Consideration is required for this extension.
3. Academic Consideration requests may be granted only for extenuating circumstances that began before the deadline and lasted longer than the extension. Students must not provide medical or compassionate documentation to the instructor.

If the student is dissatisfied with the decision of the instructor or does not receive a decision from the instructor, a written request for relief must be submitted to the Undergraduate Chair of the School offering this course, within three (3) weeks from the date that the mark was issued.

Rounding of Grades (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or ‘giving away’ of marks. Please don't ask me to do this for you; the response will be “please review the course outline where this is presented”.

Information about late or missed assessments:
