Calendar Course Description (including prerequisites/anti-requisites):

Promotes understanding of the fundamentals, procedures, and laboratory techniques of physical, chemical and biochemical analyses (qualitative and quantitative) of foods. Emphasis on utilization and/or application in food science, public health, sanitation, foods and nutrition.

Antirequisite(s): The former Foods and Nutrition 2350A/B.

Prerequisite(s): Biology 1290B. **Pre-or Corequisite(s):** Foods and Nutrition 3342A/B.

Notes:

1. Participation and Lab Performance (10%): Participation is evaluated continuously throughout the course based on preparedness, engagement in discussions, teamwork, and adherence to lab safety protocols. Students are expected to attend and actively participate in all lab sessions. Academic Consideration requests will only be reviewed in cases of extended absences that significantly impact ongoing participation.
2. Lab Reports (63%): Students must submit 9 lab reports, each worth 7%, within one week of the corresponding lab session. Late submissions will be penalized at a rate of 1% per hour beyond the deadline. Students may submit a lab report up to 24 hours late without a penalty if extenuating circumstances arise. No Academic Consideration request is required for this 24-hour extension. Academic Consideration requests may be granted only for circumstances that began before the deadline and extended beyond the 24-hour grace period. Students must not provide medical or compassionate documentation directly to the instructor.

- Project Outline (5%) and Group Project (Presentation 12%, Written Report 10%): These assessments are critical components of the course and are collectively considered designated assessments. Students must provide documentation for any absence or delay in submission or presentation. Approved Academic Consideration requests for missed deadlines will result in a deferred submission date, or reallocation of grade weight, as determined appropriate. Students must not submit medical or compassionate documentation to the instructor.

Oral presentation

A presentation (approximately 15 minutes in length, followed by 5 minutes of questions and answers, and a discussion, total: 20 minutes) at the assigned session will facilitate discussion and promote critical thinking among students. The oral presentation includes a title, outline, introduction (including history and term definitions), objective, body (method, results, and gaps in knowledge), discussion, conclusion, suggestions for future work, and acknowledgments.

Written report

The essay includes the title page, abstract, introduction, relevant literature (results and discussion depend on your subjects), current gaps in knowledge, a suggestion for future work, conclusion, and references (12 pages, double-spaced, except references).

General information about assessments

- All assignments are due at 23:59 EST on Tuesday, one week after each lab, unless otherwise specified.
- Students are responsible for ensuring that the correct file version is uploaded; incorrect submissions including corrupt files could be subject to late penalties (see below) or a 0.
- Written assignments will be submitted to Turnitin (statement in policies below).
- Students will have access to Turnitin reports before their submission is graded. Students may have 2 submissions to Turnitin.
- A student might not receive the same grade as their group members if it is determined that the distribution of work was not equal.
- After an assessment is returned, students should wait 24 hours to digest feedback before contacting their evaluator; to ensure a timely response, reach out within 7 days.
- Prior to the filing of a written request for relief, students must attempt to resolve the concern regarding a mark or grade through informal consultation with the instructor. If the student is dissatisfied with the decision of the instructor or does not receive a decision from the instructor, a written request for relief must be submitted to the Undergraduate Chair of the School offering this course, within three (3) weeks from the date that the mark was issued.

The table below outlines University-wide grade descriptors.

Rounding of Grades (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or 'giving away' of marks. Please don't ask me to do this for you; the response will be "please review the course outline where this is presented".

Information about late or missed assessments:

- Assignments are due on the specified date and time. The mark will be reduced by 10% per day on assignments submitted within 7 days of the due time. Assignments submitted after 7 days will not be accepted for marking, unless accompanied by documentation to confirm a personal issue.

Course-specific conditions:

- Failure to attend at least 75% (7 labs) of laboratories or studios will result in a laboratory or studio grade of "incomplete" in the course. Completing the laboratory/studio will be necessary to receive credit in the course.
- Participation and lab performance marks will be evaluated based on student attendance in the lab. If a student misses any lab session, he/she will lose a participation grade. The reporting mark will also be calculated, constituting 50% of the total mark.

INC (Incomplete Standing): If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

SPC (Special examination): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. If the class has a makeup exam, the student is expected to write the makeup exam. If the class doesn't have a makeup exam or the student misses the makeup exam for reasons approved by the Academic Advising Office, the student will write the exam the next time the course is offered. Outstanding SPCs will reduce the course load for the term the exam is deferred as outlined in [Types of Examinations](#) policy.
