Calendar Course Description (including prerequisites/anti-requisites):

This course investigates the important food/food components for individuals involved in chronic (regular) exercise programs and/or competition, i.e., athletes. The focus is on understanding how dietary needs are affected by regular, vigorous physical activity and the mechanisms responsible for any performance enhancement/decrement resulting from the supplementation of specific foods or food components.

Prerequisite(s):

Antirequisite(s): Foods and Nutrition 3339A/B, Kinesiology 3339A/B.

My Course Description

This course is designed to provide students with an overview of the role nutrition plays in supporting exercise/training among a variety of populations and focuses on the nutritional strategies that support athletes at all levels, during all stages of training and performance.

5. Develop knowledge translation skills by developing educational materials for athletes.
