**Calendar Course Description (including prerequisites/anti-requisites):**

This course introduces students to the fundamental principles and practices of counselling, focusing on history, theories, techniques, assessment, and ethical considerations. Understanding of the therapeutic process involves interactive discussions, role-playing, video demonstrations, case studies, and critical reflection to gain self-awareness and cultural competence, enhancing capacity to work with diverse populations.

**Antirequisite(s):** The former Family Studies and Human Development 2235.

**Prerequisite(s):** Any 0.5 course from any department in the Faculty of Health Sciences, the Department of Anthropology, the Department of Gender, Sexuality and Women's Studies, the Department of Psychology or the Department of Sociology; or permission of the Department.

**My Course Description**

This introductory counselling course explores major theories, techniques, and practices that shape effective counselling relationships across diverse contexts such as education, justice, health, and community settings. Students will delve into ethical and legal considerations, multicultural counselling, research, and assessment while developing critical skills through engaging activities like debates, group presentations, and role-plays. Emphasis is placed on self-awareness, professional wellness, and cultural competence, ensuring students understand how navigate complex counselling challenges. With online asynchronous lectures complemented by in-person workshops and guest speakers, this course provides a dynamic and immersive learning experience.

**Learning Outcomes**

Upon successful completion of this course, you will be able to:

1. Compare and contrast the five major counselling theories, including cognitive and behavioural, experiential and humanistic, psychodynamic, somatic, and systemic and collaborative.
2. Demonstrate basic counselling skills such as active listening, empathy, and effective questioning techniques through role-playing and peer feedback exercises.
3. Apply ethical principles and guidelines in counselling practice, including confidentiality, informed consent, and professional boundaries.
4. Evaluate the impacts of cultural diversity on counselling practices to develop strategies for providing culturally sensitive and competent counselling to diverse populations.
5. Analyse their worldview based on their knowledge and self-reflection activities to enhance their self-awareness and understand how their personal values and experiences influence their counselling approach.
6. Evaluate the effectiveness of counselling interventions and the ways of assessing the progress of clients with attention to current research evidence.
7. Apply modern technologies in counselling, including online counselling platforms with attention to their implications for practice based on ethical, legal, and privacy concerns.

### Course Content and Schedule

- Historical background of counselling and current and emerging understanding
- Distinguishing features of the counselling relationship and ethical, legal, cultural, training, certification, licensure, and other important considerations
- Theories and techniques frequent used in the counselling relationship
- Important considerations when working with clients in diverse contexts
- Use of diverse counselling modalities, counselling microskills, and techniques
- Formation, characteristics, and personal and professional practices of an effective counsellor

- 3) A working understanding and knowledge of key counselling concepts in an online final exam.
- 4) A critical reflection paper focusing on your worldview, including beliefs about people, problems, and change as well as how these factors will influence your approach as a counsellor to counselling.

Notes:

1. Designated Assessment: The written assessments have been designated as being central to the evaluation of learning outcomes in this course. Accordingly, students must provide documentation for any absence from this evaluation. If you miss this evaluation, you must complete the assessment as agreed based on accommodation.

2. Students are expected to submit written assignments by the deadlines listed. Should extenuating circumstances arise, students are permitted to submit their assignment up to 48 hours past the deadline without a late penalty. No Academic Consideration is required for this extension. Students submitting their assessment beyond the extended deadline will receive a penalty of 10% per day that it is late. Academic Consideration requests may be granted only for extenuating circumstances that began before the deadline and lasted longer than the extension. Students must not provide medical or compassionate documentation to the instructor.
3. You cannot use undocumented absences for final exams.

### General information about assessments

- All assignments are due at 23:59 EST unless otherwise specified.
- Students are responsible for ensuring that the correct file version is uploaded; incorrect submissions including corrupt files could be subject to late penalties (see below) or a 0.
- Written assignments will be submitted to Turnitin (statement in policies below).
- Students will have access to Turnitin reports before their submission is graded. Students may have 2 submissions to Turnitin.
- A student might not receive the same grade as their group members if it is determined that the distribution of work or effort was not equal.
- After an assessment is returned, students should wait 24 hours to digest feedback before contacting their evaluator; to ensure a timely response, reach out within 5 days.
- Prior to the filing of a written request for relief, students must attempt to resolve the concern regarding a mark or grade through informal consultation with the instructor. If the student is dissatisfied with the decision of the instructor or does not receive a decision from the instructor, a written request for relief must be submitted to the Undergraduate Chair of the School offering this course, within three (3) weeks from the date that the mark was issued.

### Rounding of Grades (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or 'giving away' of marks. Please don't ask me to do this for you; the response will be "please review the course outline where this is presented".

### Information about late or missed assessments:

- Late assessments without academic consideration will be subject to a late penalty of 10% per day to a maximum of five days.
- Mixed tests or makeup tests will be accommodated online based on approved academic consideration.

### Course-specific conditions:

- Tutorial participation and presentations are required to pass this course.
