Calendar Course Description (including prerequisites/anti-requisites):

This course offers a multidisciplinary approach to the study of human growth and development in a Canadian context. With chronological unfolding of developmental events, students will learn about development from conception to middle childhood in culturally and conceptually meaningful ways.

My Course Description

This course offers a multidisciplinary approach to the study of early childhood development in a Canadian context. With chronological unfolding of developmental events, students will learn about child development in ways that are culturally and conceptually meaningful to them. This course will have an experiential learning component for exploring child development, with emphasis on integrating developmental theories relevant to infancy and early childhood with contemporary research findings for practical application purposes.

Learning Outcomes

Upon successful completion of this course, you will be able to:

1. Demonstrate an understanding of a variety of theoretical perspectives on human development from the prenatal period through middle childhood and apply these theories in a real-life setting.
2. Develop an understanding about physical, cognitive, and social-emotional development from the prenatal period through middle childhood and gain an awareness of cultural diversity and its implications in childhood development.
3. Explain enabling factors contributing to healthy development of children, using a strengths-based approach.

4. Develop your research and inquiry skills in an ethical manner by investigating issues related to child development and actively engaging in an experiential learning opportunity.
5. Apply your ability to effectively communicate the results of your research to promote awareness around healthy childhood development in diverse communities.

1. You will have up to 3 optional, ungraded practice quizzes in this course. These quizzes are mostly designed to test your knowledge of course materials and learnings. You will have 2 tests.
2. Designated assessment: Test 2 is considered central to the assessment of learning outcomes in this course. Accordingly, students must provide documentation for any absence from this evaluation. If you miss Test 2, you must complete the makeup assessment as follows: discuss potential make-up date with the instructor and write the make-up. The makeup assessment is an extension of the Test, and so you will need to present documentation for this assessment, should you need to miss it. Please note that there is only one makeup assessment per Test. If you miss the make-up test, a mark of zero will be applied.
