## KIN 4492G Independent Study in Kinesiology

#### CALENDAR DESCRIPTION

Reading and discussion on selected topics in Kinesiology agreed upon through consultation between the student and the supervising professor. All fourth year honors Kinesiology students and, in some cases third year students, are eligible to enroll, subject to Faculty procedural guidelines and approval.

**Pre-requisites:** Registration in fourth year Honors Specialization in Kinesiology and permission of Kinesiology.

### Note regarding prerequisite checking

You are responsible for ensuring that you have successfully completed all course prerequisites, and that you have not taken an anti-requisite course. Lack of a pre-requisite or the completion of an anti-requisite cannot be used as a basis for appeal. If you are found ineligible for a course, you may be removed from it at any time and you will receive no adjustment to your fees. This decision cannot be appealed.

**Independent Study Project.** The nature of the project and its specifications are organized and agreed to, between the student and his or her faculty mentor. The project in its entirety is to be submitted no later than the last day of classes for the term. The paper should be approximately 2,000 words in length, not including references, title page, and abstract. It should be double-spaced, and formatted using a font size no smaller than 12 points. The report must be in a format deemed to be acceptable as a scholarly paper in either the socio-cultural or bioscience realms.

**Note:** All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between Western University and Turnitin.com (http://www.turnitin.com)

The University recognizes that a student's ability to meet his/her academic responsibilities may, on occasion, be impaired by medical illness. Illness may be acute (short term), or it may be chronic (long term), or chronic with acute episodes. The University further recognizes that medical situations are deeply personal and respects the need for privacy and confidentiality in these matters. However, in order to ensure fairness and consistency for all students, academic accommodation for work representing 10% or more of the student's overall grade in the course shall be granted only in those

cases where there is documentation indicating that the student was seriously affected by illness and could not reasonably be expected to meet his/her academic responsibilities.

A UWO Student Medical Certificate (SMC) is required where a student is seeking academic accommodation. This documentation should be obtained at the time of the initial consultation with the physician or walk-in clinic. Documentation is required for non-medical absences where the course work missed is more than 10% of the overall grade. Students may contact their Faculty Academic Counselling Office for what documentation is needed.

Whenever possible, students who require academic accommodation should provide notification and documentation in advance of due dates, examinations, etc. stating specific reasons and dates. Students must follow up with their professors and their Academic Counselling office in a timely manner. Documentation for medical requests for accommodation must be submitted within two (2) business days after the end date on the documentation, to the appropriate Academic Counselling Office of the student's Faculty of registration. For KIN students, you may go to the School of Kinesiology in 3M Centre room 2225. It will be the Academic Counselling office that will determine if accommodation is warranted and **NOT** the instructor.

An "Accommodation Consideration Request Form" found online or in the Kinesiology Undergraduate Office must be submitted to the Kinesiology Academic Counselling office. These documents will be retained in the student's file, and will be held in confidence in accordance with the University's Official Student Record Information Privacy Policy.
