Course/University Policies

Lateness/Absences: Assignments are due when noted above, and will not be accepted late, except under medical or other compassionate circumstances. The course policy is not to allow make-ups for scheduled midterms, presentations or final exams, nor to assign a grade of Incomplete without acceptable and verifiable medical (or equivalent compassionate) reasons.

Acceptable reasons might include hospital stays, serious illness, family emergencies (like serious accidents or illness, death) or similar circumstances.

Accommodation For Illness:

Illness may be acute (short term), or it may be chronic (long term), or chronic with acute episodes. The University further recognizes that medical situations are deeply personal and respects the need for privacy and confidentiality in these matters. However, in order to ensure fairness and consistency for all students, academic accommodation for work representing 10% or more of the student's overall grade in the course shall be granted only in those cases where there is documentation indicating that the student was seriously affected by illness and could not reasonably be expected to meet his/her academic responsibilities. Students must follow up with their professor and their Academic Counselling office in a timely manner. Documentation for medical requests (which should be obtained at the time of the initial consultation with the physician or walk-in clinic) for accommodation, must be submitted directly within two (2 business days after the end date on the documentation, to the appropriate Academic Counselling office of the student's Faculty/School of registration (KIN Undergraduate Office), not to the instructor.

A UWO Student Medical Certificate (SMC) is required where a student is seeking academic accommodation.
