# My Course Description

This course introduces psychological principles that influence sport and exercise behaviour. Student will examine how personality traits, motivation, and emotions impact performance and participation. Key social processes are also explored. Through interactive lectures and real-world examples, students will gain foundational insight into the psychological dynamics influencing physical active lifestyles.

### **Learning Outcomes**

Upon successful completion of this course, you will be able to:

- 1. **Describe** core concepts and theories in sport and exercise psychology.
- 2. **Explain** the relationship between psychological factors and sport and exercise performance and participation.
- 3. **Apply** core concepts and theories in assessing athlete and exerciser behaviour.
- 4. **Analyze** how individual and group differences influence performance and participation.
- 5. **Evaluate** strategies used to enhance sport and exercise performance and participation.
- 6. **Reflect critically** on personal attitudes and experiences with sport and exercise using core concepts and theories.

- 1. This course has 20 in-class participation quizzes (1 question worth 1 mark each). The 10 quizzes with the highest marks will be counted towards your final grade. Academic Consideration requests will be denied for any missed/incorrect quizzes.
- 2. Students are expected to submit this assignment by the deadline listed. Should extenuating circumstances arise, students are permitted to submit their assignment up to 72 hours past the deadline without a late penalty. No Academic Consideration is required for this extension. Students submitting their assessment beyond the extended deadline will receive a penalty of 1% per hour that it is late.
