## **My Course Description**

Do you intend to work in a sport, physical activity, or health related organization? If yes – then this course will be essential for you. Organizations are an important feature in all realms of society, and kinesiology is no different. You are likely here because you have an interest in sport/physical activity/health and therefore the functioning of the organizations that service these activities. This course is intended to provide you with an overview of organizational management from a macro-perspective as it applies to sport, physical activity, health and recreation related organizations. Given this approach, we will be focusing on the managerial components of decision making and communicating, as well as the various functions of management—planning, organizing, leading, and evaluating. Throughout the course, you are expected to examine and analyze issues and theoretical perspectives, and apply this knowledge to the practice of management in sport, recreation, physical activity, and health settings.

## **Learning Outcomes**

Upon successful completion of this course, you will be able to:

1. **Identify and delineate** theoretical terms, concepts, and philosophies related to sport, physical activity, and recreation management.
2. **Analyze and compare** the context of the kinesiology management with the related industries.
3. **Synthesize** management concepts and research through Experiential Learning.
4. **Develop** writing skills and project development related to management in kinesiology.
5. Begin to **develop abilities** to *critically reflect* upon own learning and relate to the topics discussed in class.

### **Rounding of Grades** (for example, bumping a 79 to 80%)

This is a practice some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or ‘giving away’ of marks. Please don’t ask me to do this for you; the response will be “please review the course outline where this is presented”.

### **Information about late or missed assessments:**
