Calendar Course Description:

A gross anatomical description of the structure and function of the human body focusing on systems responsible for maintaining the body (respiratory, digestive, urinary, endocrine), and for its continuation through the transmission of genes (reproductive system, developmental anatomy). Emphasis on physiological functions as they relate to the anatomical structure.

Anti-requisite(s):

Anatomy and Cell Biology 3200A/B, the former Anatomy and Cell Biology 2221, Kinesiology 3222A/B, Health Sciences 3300A/B.

Prerequisite(s):

Any of the following: Kinesiology 1060A/B; Kinesiology 2222A/B; Health Sciences 1300A/B; Health Sciences 2300A/B; Nursing 1330A/B; Anatomy and Cell Biology 2200A/B.

You are responsible for ensuring that you have successfully completed all course prerequisites, and that you have not taken an anti-requisite course.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. My Course Description

Welcome to **Anatomy of the Human Body!** Our teaching team is delighted to have you join us this term. In this course, we will build upon content from Systemic Approach to Functional Human Gross Anatomy (KIN 1060 and HS 1300) by learning the anatomy of visceral systems within the body, with specific attention to the **nervous** (brain, spinal cord, and neurons), **endocrine** (glands and hormones), **digestive** (gastrointestinal tract and accessory organs), **urinary** (kidneys and bladder), and **reproductive** (gonads and genitalia) systems. Anatomy is a fundamental discipline that will support your understanding of core concepts related to health and disease in your degree and career ahead. This course is delivered in a blended format – content will be delivered online, but each week we will meet in person in a lecture hall for flipped-classroom application activities and guest lectures. Plus, one-hour weekly laboratory periods will give you the opportunity to work in groups, answer big-picture questions with TAs, and explore the anatomical structures in a hands-on setting. The course is cumulative and voluminous in nature, so we encourage you to **stay involved**, **ask questions**, and **participate** as much as possible – be sure to complete the online lecture modules before coming to class and lab. We look forward to meeting you soon!

Overall, the spirit of this course is to foster authentic learning, critical thinking, active questioning, and an appreciation for health and disease from a gross anatomical perspective

Learning Outcomes

By the end of this course, a successful student should be able to:

- Communicate the locations, functions, and movements of bodily structures using correct anatomical terms.
- Explain the basic structure of the nervous system, differentiating between the central and peripheral nervous systems, as well as between the somatic and autonomic nervous systems.
- Describe how the autonomic nervous system regulates basic homeostasis in the body.
- Identify major surface anatomy landmarks, bones, joints, muscles, nerves, organs, and vessels related to the upper limb, lower limb, and trunk by name, location, and function.
- Describe neuronal conduction, muscle contraction, key events of the cardiac cycle, and mechanics of breathing.
- Explain how the heart and lungs interact to form the cardiorespiratory system, differentiating between systemic and pulmonary circuits.
- Explain and predict functional implications of musculoskeletal, neural, and cardiorespiratory changes in aging, exercise, and injury based upon clinical signs and symptoms.



• Unit Quizzes (24%)

- o **Format:** Online; 15 multiple choice questions; 30min; Forward-only.
- Flexibility:
 - Lengthy submission window: Quizzes open at 12:00pm (noon) and are due at 11:59pm via OWL Brightspace on the dates listed above.
 - Drop lowest grade: There are five quizzes in total; however, only the top four scores will be counted, each worth 6%. This allows you to miss one quiz without penalty. <u>This includes any missed quiz, with or without</u> academic considerations.
- Conditions: No make-ups or extensions. If more than one quiz is missed without approved academic considerations for <u>all missed quizzes</u>, only the first missed quiz will be dropped and a grade of zero will be assigned to all others. If academic considerations are approved for <u>all</u> missed quizzes, the weight(s) will be redistributed onto the completed quizzes or the final examination. The unit quizzes are flexible assessments that are not eligible for undocumented absences.

Examinations (45%)

- Midterm examination (15%):
 - Format: On-paper (in-person); 35 multiple choice questions; 1hr (in class).
 - Content: All content covered in Unit 1 and Unit 2.
 - Flexibility: Not applicable. This assessment has been designated as being central to the assessment of learning outcomes in this course (<u>designated</u> <u>assessment</u>). Accordingly, students must provide documentation for any absence from this evaluation through the <u>academic considerations</u> portal.
 - Conditions: There is no make-up examination. Students who miss the midterm examination with documentation and approved academic considerations will have the 15% redistributed to the final examination. A grade of zero will be assigned for a missed midterm examination without approved academic considerations supported by documentation.

Final examination (30%):

- **Format:** On-paper (in-person); 70 multiple choice questions; 2hr.
- Content: All content covered in the course (cumulative).
- Flexibility: Not applicable.
- Conditions: Students who miss the final examination with documentation and approved academic considerations may write a make-up examination (date and time TBD). A grade of zero will be assigned for absences without approved academic considerations supported by documentation.

• Peer Collaboration (31%)

Group Assignment (20%)

- Format: Create a science communication tool (format chosen by each group); final presentation (10min); peer evaluation.
- Content: Anatomy-based clinical or pathological topics will be discussed and assigned to each group in the first two weeks of class.
- Flexibility: This is an ongoing project with graded formative components (each with lengthy submission windows; thus, ineligible for academic considerations) that are placed throughout the duration of the course. Except for the peer evaluation grade, all grades are shared by all members of the group. It is up to each group to define the roles and responsibilities of each member. A student might not receive the same grade as their group members if it is determined that the distribution of work was not equal.
- Conditions: No make-ups or extensions. Group work sessions will be scheduled throughout the semester in class and the laboratory sessions, but students must also organize additional meeting times on their own. See the Group Assignment details on OWL Brightspace for more information. If a group member is to miss the final presentation with approved academic considerations, their absence must be communicated to their group members and a plan should be established for other ways the absent member can contribute equally. A presentation grade of zero will be assigned for absences that do not meet these criteria.

Laboratory Attendance (5%)

- Format: Attend the full length of each laboratory session and check in with the TA at the end of each session to earn one grade point. The total number of sessions attended will be divided by the number of graded sessions in the course for a fraction of the 5% total.
- Content: Topics covered in each week of class.
- Flexibility: Not applicable.
- Conditions: No make-ups or extensions. If laboratory sessions are missed with approved academic considerations, the missed sessions will be removed from the denominator in the grade calculation.

PeerWise (6%)

- Format: Creating at least 10 multiple choice questions (0.2% each, maximum of 2%); answering at least 20 multiple choice questions (0.2% each, maximum of 4%); graded for completion (not correctness).
- Content: Questions written or answered can cover any topic in the course.
- Flexibility: Long completion window (entire duration of the course).
- Conditions: No make-ups or extensions. Not eligible for academic considerations.

After an assessment is returned, students should wait 24 hours to digest feedback before contacting their evaluator; to ensure a timely response, reach out within seven days.

Any grade appeals on term work must be initiated with the instructor within 3 weeks of the grade being posted. See the <u>University Policy on Undergraduate Student Appeals</u> for more information. The table below outlines University-wide grade descriptors.

Rounding of Grades (for example, bumping a 79 to 80%): This is a practice that some students request. The final grade documented is the grade that you have achieved. There is no rounding to the next grade level, or 'giving away' of marks. Please don't ask me to do this for you; if any response is given, it will be "please review the course outline where this is presented".

INC (Incomplete Standing): If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned. Students with INC will have their course load in subsequent terms reduced to allow them to complete outstanding course work. Students may request permission from Academic Advising to carry a full course load for the term the incomplete course work is scheduled.

SPC (Special Examination): If a student has been approved by the Academic Advising Office to write a Special Examination and the final exam is the only outstanding course component, an SPC will be assigned. If the class has a makeup exam, the student is expected to write the makeup exam. If the class doesn't have a makeup exam or the student misses the makeup exam for reasons approved by the Academic Advising Office, the student will write the exam the next time the course is offered. Outstanding SPCs will reduce the course load for the term the exam is deferred as outlined in Types of Examinations policy

Absence from Course Commitments

Examples of flexibility in assessment include when there are assessments not required for calculation of the final grade (e.g. 8 out of 10 quizzes), when there is flexibility in the submission timeframe (e.g. 72 hour no late penalty period), or when timed assessments (e.g., quizzes) are available over an extended period of time (e.g., when you are given a 72 hour time period to start – and finish – the assessment).

Please note that academic considerations in this course are granted by the academic advisors in your home unit and implemented by the instructor of this course in accordance with information presented in this course syllabus. Supporting documentation for academic considerations for absences due to illness should use the <u>Student Medical Certificate</u> or, where that is not possible, equivalent documentation by a health care practitioner.
