#### Calendar Course Description (including prerequisites/anti-requisites):

This course provides students with the opportunity to put theory into practice within the sport system available at Western. Students will work closely with athletic teams in assigned areas

# **Our Course Description**

This course will provide the student with hands on learning experiences in a sport and clinical setting as the student trainer for an assigned varsity athletic team. You will be responsible for the pre and post- practice care of the athletes on your team before, after and during practice and game periods. As such you will be directly responsible for the on-field, acute care of these athletes. Class time will be spent refining your acute injury assessment and management skills, as well as some basic rehabilitation skills. The student trainers will also be scheduled at the Fowler /Kennedy Sport medicine varsity clinic in Alumni hall clinic.

It should be understood that the practicum is in effect for the full academic year and, although responsibilities with a team may cease prior to the completion of the academic year, the student will be required to attend classes and to lend service when or as necessary. As a student trainer, you will be required to attend all practices and any scheduled games. There may be various invitational events, throughout the year, that may require student trainers on-site. Tournaments, meets, etc. will be covered utilizing student trainers enrolled in Kinesiology 4585 on a scheduled format

This is a full year course. In addition to participation grades from player and coaches, there will be participation grades given for attending class and the varsity clinic. We will discuss these expectations in class
