Course Description:

Aging is a major factor impacting healthcare delivery in the 21st century, and older adults are the core consumers of health care. In this course, students apply clinical decision-making by correlating physiologic, psychological and environmental interactions with older adults while focusing on cultural, social, ethical, and legal concepts of care.

Expanded Description:

In this course, students explore the fundamental principles of aging and personal and family-centred nursing care for the older adult population in a variety of health care settings. Students will learn the normal aging process and the impact of diseases in older age. Students will learn how to approach geriatric assessments given the complexities of this population and understand the role of interprofessional team collaboration in caring for older adults. Students also develop an understanding of the existing resources, policies and legal aspects of senior care prevailing in the community based on Ministry of Health and Long-term Care guidelines. This course will encourage students to engage actively and acknowledge the various community services of geriatric care and how to incorporate those into their future nursing careers.

Corequisite: Laboratory & Clinical Application: Engagement in Care

1. Explore the fundamental principles of aging, including the meaning of person and family-centred nursing care for the older adult population in a variety of health care settings
2. Explore the social determinants of health and the impact of health inequities on the aging trajectory
3. Identify nursing interventions for improving quality of care, based on the needs of older adults and their families
4. Explain how the interprofessional healthcare team collaborates with older adult populations and their families to achieve client-centred goals
5. Examine health policies, legal and ethical issues, and end-of-life care in the older population, considering ethnic and cultural background.
6. Evaluate the effectiveness and availability of health care programs and services for older adults.

1. **Reflective Assignments: 10% of course mark**
This assignment encourages you to explore and critically assess your perceptions and beliefs about older adults and their interactions with the health care system. Students will individually complete 2 written reflections worth 5% each. Assignment details will be discussed in class and posted on the course site. Reflection #1 is due September 19, and Reflection #2 is due November 21, by 2355h.
2. **Test #1: Multiple Choice and Short Answer Test – 25% of course mark**
Due: Week 5 during regularly scheduled class time (1 hour)
This test will include material from weeks 1-4.
If a student is absent for this test, they are to contact the academic counsellor and course professor as soon as possible and before the test begins. If an accommodation is warranted and granted, a make-up assignment will be arranged. The make-up assignment *may* be in a format different from the short answer test, for example, an essay or reflective assignment.
3. **Test #2: Multiple Choice and Short Answer Test – 25% of course mark**
Due: Week 9 during regularly scheduled class time (1 hour)
This test will include material from weeks 5-8.
If a student is absent for this test, they are to contact the academic counsellor and course

professor as soon as possible and before the test begins. If an accommodation is warranted and granted, a make-up assignment will be arranged. The make-up assignment *may* be in a format different from the short answer test, for example, an essay or reflective assignment.

4. **Final Exam – 40% of course mark**

Due: Scheduled during the examination period. Readings, online discussions, and course content from weeks 1 to 12 will be included. The test will consist of multiple-choice questions and be 2.5 hours in length.
