N4320 Professional, Ethical and Legal Obligations in Nursing: A Critical Appraisal

Calendar Description:

This course will critically review ethical theories, the legal and ethical aspects of nurses' roles, and nursing's commitment to healthy public policy, social justice, and advocacy.

Expanded Course Description:

This course is organized based on the College of Nurses of Ontario (CNO) Conceptual Framework for Organizing Competencies (CNO, 2014). In this course, learners will critically examine professional practice issues specifically focused on professionalism, nursing regulation, practice standards, ethical and legal aspects of nursing. This course also examines the evolving roles within nursing and addresses professional responsibility and accountability to healthy public policy, social justice, advocacy and patient safety. This course integrates multiple ways of knowing with emphasis on emancipatory knowing.

Course Weight & Delivery:

0.5 FCE theory lecture course. Flexible delivery includes in-person and online classes.

Course Goals:

1. Examine the leadership and professional culture of the nursing profession
2. Reflect on the historical and contemporary issues and trends in nursing and explore the influence of social, political, and personal power structures in assuming professional roles
3. Develop in-depth understanding of health professional legislation and nursing regulation including professional requirements as outlined in the CNO *Professional Standards & Standards of Practice for Registered Nurses*; CNO *Ethical Values*, and the CNA *Code of Ethics for Registered Nurses*
4. Critically examine selected moral, ethical and legal issues influencing nurses' ability and capacity to provide ethical, safe, knowledge-based quality health care from a health promotion and caring perspective in a variety of settings and contexts, and with a diverse client population across the life span
5. Develop an understanding of the fundamental elements of patient safety and nursing's role in contributing to a culture of patient safety.
6. Engage in learning activities with colleagues that promote debate, collaboration, consultation, cohesion, critical thinking, caring and reflection
7. Incorporate scholarship and critical reflection skills into one's own learning and nursing practice
8. Apply a reflective, inquisitive, self-evaluative, responsible, and accountable attitude and behaviour with a commitment to lifelong learning

How this course will contribute to your development as a professional nurse:

The Western-Fanshawe Collaborative BScN Program - N4320 Professional, Legal, and Ethical Obligations: A Critical Appraisal, 2025

This course provides opportunities to explore nursing as a profession, including professional rights and responsibilities, as well as legal and ethical parameters. The course promotes the learners' understanding of the purpose and function of professional nursing regulatory organizations and associations, particularly in relation to ethical and legal elements of professional practice and the maintenance and improvement of the standards of care. Knowledge of course concepts is integrated through interactive learning activities, including analysis of case studies, among other learning strategies. These learning activities are designed to engage learners in critical reflection of professionalization, professionalism, and the professional practice of nursing. Opportunities will be provided for learners to reflect on their professional growth as beginning practitioners and to share their own nursing practice experiences with others.

How this course will contribute to your development as an interprofessional team member:

This course will provide students with insights as to how nurses enact their professional, legal and ethical obligations within an interprofessional environment. Learners will explore how professional standards guide their interactions with other members of the interprofessional team.

How we will work together:

In this course, learning and teaching are a shared responsibility. The instructor's role is to guide, facilitate and support learning. As a learner, it is expected that you will be prepared to actively engage in the course material while grounded in reflective and critical thought. The course and accompanying learning activities are designed to foster discussion, debate, and critical examination of concepts relevant to professional, legal, and ethical aspects of nursing practice. Weekly presence and visits in the course site are expected since messages and updates are posted by the course instructor regularly. Group work will facilitate learning, and your active participation will support collaboration and sharing knowledge together. In order to create an interactive learning environment in the course site, learners will be asked to share within groups, their understanding of course material, their experiences, and to engage in reflection on their learning.

1. Quality Assurance Learning Plan (20%)

Due: September 28 at 11:55 PM

(Students should begin working on this assignment once the term starts. If you are in placement, plan to ensure you can complete this assignment on time).

The purpose of this assignment is to familiarize yourself with the process of meeting the Quality Assurance requirements for the College of Nurses of Ontario (CNO) by engaging in self-reflection and identifying ways to become a lifelong learner.

Process:

1. Reflect on a situation from your clinical practice that provides an opportunity for growth and development.
2. Using the template found on Brightspace, complete each section to reflect on your experiences, strengths, and opportunities for professional development.
3. Based on your reflection:
 - a. identify two (2) learning goals using the SMART goal format
 - b. link your goals to the CNO's Code of Conduct
 - c. identify three (3) learning activities for each goal
 - d. reflect on the experience of creating a learning plan.
4. The completion of the independent study and readings in Week 2 will assist you in completing this work.
5. Submit the assignment electronically to the assignment page in the course site.
6. Your paper must be in MS Word format on the template provided, using 12-font and single-spaced.
7. **Title page and reference list are not required.**
8. The file extension for the uploaded assignment must include the student's surname, initial and name of assignment. e.g. De GrasseA_Quality Assurance Plan

2. Online Quiz #1 Ethics (10%)

This online quiz will be based on readings and activities from Weeks 3 and 4 on Ethical Practice. The quiz is time-limited with only one submission allowed. It can be taken anytime during the designated available time.

3. Online Quiz # 2 Legal Context and Legislation (10%)

Date: Available October 14 at 8:00AM to October 20 at 11:55PM

This online quiz will be based on readings and activities from Week 5 and 6 on Legal Context and Legislation. The quiz is time-limited with only one submission allowed. It can be taken anytime during the designated available time.

4. Group Case Study Assignment (30%)

Due: November 16 at 11:55 PM

The Case Study assignment will be completed in groups of six (6). The assignment can be started **any time after week 4** (ethical practice content), and it is recommended that you work with other students in your placement block for ease of collaboration.

The purpose of this assignment is to explore, critically analyze, and respond to a current ethical and legal issue facing the nursing profession in today's health care context. This assignment will reflect your ability to work as a group and to apply course theory and concepts to professional nursing practice. Case scenarios, marking rubric and assignment template will be available on the course Brightspace site.

Process:

1. Choose **ONE** of the case scenarios provided on the course Brightspace site and use the template provided
2. Following the template, summarize the case chosen and one (1) possible course of action
3. Complete the analysis of the case by considering the chosen course of action from a theoretical perspective, considering the values of the individuals, ethical principles involved and appropriate practice standards/guidelines from the College of Nurses of Ontario
4. Describe an alternative course of action and why it was not chosen by the group.
5. Reflect on how the process of completing this case analysis will inform your nursing practice in the future
6. Use of at least six evidence-informed scholarly articles and other sources of knowledge to justify your analysis
7. One student of the group will submit the assignment electronically to the assignment window in the course site – your paper must be in MS Word format on the template provided
8. The file extension for an uploaded assignment must include all students' surname, initial and name of assignment. e.g. AhmedM_DeGrasseA_DeguchiC_McIntoshS_Group Case Study

Criteria for evaluation:

A marking rubric is available on the course site. APA formatting is required for all references, including a reference list and title page.

5. Final Exam (30%)

The final exam will be based on course content and will focus on application of learning to situations one might find in practice. The exam will be administered in-person with additional exam details made available on the course site.
