Course Description:

Health care systems have undergone profound change in the last decade due to changing demographics, funding constraints, new and emerging technologies and a significant rise in chronic diseases. This course examines new and emerging trends in health care at provincial, national and international levels to prepare students for future careers in a changing health care environment.

Class Schedule and Format:

Classes will be a mixture of lecture, discussion, guest speakers and group work. Students are responsible for assigned readings, and to be prepared to discuss them in class. Attendance and participation in class is expected. Students are encouraged to be actively engaged in class presentations and group participation as undergraduates because the "real world" makes these demands on them routinely. Most weeks will have some classes devoted to a lecture and another to individual and/or group work. Students will be randomly assigned to groups throughout the class. Students are encouraged to bring a computer/tablet to class because there will be information retrieval exercises during the class time.

Course Materials

There is no required textbook for this course. However, there will be some **mandatory readings/articles** posted on OWL. A draft reading list will be available at the start of the course, and will be updated regularly on OWL. In general you can expect 2-3 readings, and/or additional website/links to explore each week.

Evaluation

Mid-term examination (20%) – Monday October 20th 2014

There will be a mid-term examination in class on Monday October 20th lasting 50 minutes covering all material discussed in the course (including online material provided) up to and including October 15th. The format of the examination will be a combination of multiple choice questions and short written answers.

In the event that the mid-term exam is missed for medical reasons or extenuating circumstances, appropriate supporting documentation MUST BE provided. If appropriate documentation is provided, a makeup examination will be scheduled within one week of the scheduled exam.

Individual Assignment (15%) – Monday October 13th 2014

Each student will search for a media report of a health care reform or policy issue from the last two years (2013-2014). Students will submit a written report (3-page maximum) regarding this issue and THEIR OWN perspectives and opinions on the topic. The opinions stated in the assignment must be the students own thoughts but should be supported by references to published research in the health care reform or policy literature. Each write-up will include a short introduction/background on the issue chosen for of the assignment, a concise statement that articulates the importance of your topic in relation to the health care climate and a discussion of YOUR perspective on 2-3 main points that constitute the focus of the assignment. Well-organized paragraphs should be used to analyze each point. In academic writing, one paragraph consists of 5-7 sentences, and this rule must be adhered to. Each assignment must also contain a concluding paragraph, which summarizes the main topics examined and reiterates the importance of your topic. This paragraph must contain original writing and cannot be cut and pasted from the introductory paragraph.

This assignment is not meant to be an in-depth review of any specific topic; however, to contextualize your topic and demonstrate your ability to think beyond the basic media reports you must do a minimal amount of outside reading. Each write-up must cite 4-7 academic references, which does NOT include Internet sites or class references. Search engines such as Pub Med and Google Scholar are ideal places to begin your search for academic studies that relate to your topics. Use in-text citation and the APA reference style throughout, which you will find descriptions of online. Assignments will be due IN CLASS on Monday October 13th 2014. Students will also be required to submit a copy of their assignment to www.turnitin.com by the time class begins on Monday October 13th 2014.

The report must meet the following requirements:

- Title page with title of assignment, student name and number, instructor's name, course number, date of submission, number of pages.
- Printed on 8.5" by 11" paper
- Use a 12 point font
- Lines must be double-spaced
- 1" margins
- Spell checked
- Include a list of references using APA style

Group Project (25%) – Week of November 24th 2014

Students will organize themselves into groups of four. Each group will be asked to identify and select a new health care technology that they will research to identify how the technology can be used, the type of healthcare organization that may use the technology, the type of clinical conditions/programs it may be used for, the staffing and costs that may be involved in the purchase, implementation and use of the technology, and the benefits and issues associated with using the technology.

Part A - In class during the week of November 24th, the groups will be expected to provide an informal five minute description of their project to their colleagues so everyone has an overview of the technologies available and their intended uses. This portion of the assignment will constitute 5% of the overall mark.

Part B - The group will submit a report (3000 word limit) in Word, which addresses all of the identified requirements in the group project definition above. This paper must be submitted both in hard copy in class on Friday November 28th and electronically to the provided dropbox in OWL. One student in each group will upload the assignment to OWL. This portion of the assignment will constitute 20% of the overall mark.

The report must meet the following requirements:

Participation (10%) - December 1st 2014

Given the focus on group work, external presentations, and the marks allotted to attendance, you must take part in every class. Regular, punctual class attendance is critical and any absence, along with repeatedly late arrivals to class, will affect your mark. A portion of this mark (5%) will be determined by your group members who will assess your participation in the group project. In class on December 1st, each student will submit an evaluation of all members of their project group assessing their contribution to the outline, presentation, final report and project overall. This will be combined with an evaluation of the student's attendance and participation in class by the instructor.

Final Exam (30%) - TBA Scheduled by Registrar

There will be a final examination lasting a maximum of two hours covering all material discussed in the course. The format of the examination will be a combination of multiple choice questions and short written answers. The final exam date will be set by the university in the final exam period in December 2014.
