## Western University School of Health Studies HS3052A: Brief History of Drug Use

### 1.0 CALENDAR DESCRIPTION

There haven't been many topics more controversial than drugs in North America. Drug use is one of those features of humanity that goes back into prehistory, and in many ways, our current drug use isn't significantly different. This course seeks to examine present-day debates about drugs through historical, sociological, and ethical perspectives.

**Prerequisites:** Minimum of 60% [mandatory] in each of Health Sciences 1001A/B and Health Sciences 1002A/B.

**Anti-requisites:** Health Sciences 3092B section 001 if taken in 2011.

### **5.0 COURSE OBJECTIVES**

This course unpacks the history of drugs, drug use, and drug policy, particularly in Canada. We progress chronologically from prehistory to the modern era. We explore drugs and drug use from several distinct perspectives and determine the impact drug policies have had on society, especially among minorities and marginalized populations.

### 7.0 ASSESSMENT/EVALUATION SCHEDULE

**Forum** (10%): Ten questions will be posted to the **Forum** on **OWL** throughout the term. Questions are generated from weekly lectures and readings. Each student <u>must</u> provide an original response to each week's posting and comment on a fellow student's original response. Each week's original response and comment are worth a total of 1%. There are <u>no part marks</u>. Students are expected to provide thoughtful responses and comments demonstrating critical thinking and an understanding of important concepts, key terms, and prominent theories. Each response and comment must include a minimum of <u>80 words</u>. Examples are posted in the **Forum** on **OWL**.

**Midterm Exam (35%):** The midterm exam covers all assigned readings and PowerPoint materials presented from lectures 1-5. This assessment consists of 60 questions and is formatted as multiple-choice, true or false, matching, as well as fill-in-the-blanks. The exact date and time will be posted to OWL once the exam schedule is released.

**Essay** (10%): The essay is a critical reflection (reflective essay) of *Crack: Cocaine, Corruption*, & *Conspiracy* (Netflix). This paper must be between 4-6 pages (max), double-spaced, and formatted in APA style (7<sup>th</sup> edition) and is due on . Please review the rubric for more information. Late essays will be penalized 5% per day for five days. After five days, you will receive a zero.

**Final Exam (45%).** The final exam is **cumulative** and covers all assigned readings, videos, and PowerPoint materials presented in this course. This assessment consists of **75 questions** and is formatted as multiple-choice, true or false, matching, as well as fill-in-the-blanks. This exam is scheduled by the Office of the Registrar (OOR) and takes place during the summer final exam period. This assessment is **synchronous** and is to be completed via the Tests & Quizzes tool on OWL. The exact date and time will be posted to OWL once the exam schedule is released.

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating. Proctortrack (and other online proctoring software) will be used in this course.
