#### Current calendar course description

Study of specific problems in French language.

**Note**: Because this course is a course in "Special Topics in Language" there is no precise calendar description. The content of the course depends on the professor. (Please see the description below.)

#### **Course description**

French 4900A offers students a comprehensive opportunity to develop all aspects of oral language. In this course, students will learn and practice contemporary colloquial French as spoken in France today. It focuses on enhancing oral communication skills, both in production and comprehension, and enables students to understand, identify, and use various language registers and sociolinguistic features, such as the relationships between age, social class, and language. Additionally, the course aims to improve pronunciation and specific features of colloquial language, familiarize students with aspects of French culture, and refine certain grammatical elements, including gender, tenses, and agreement. While the majority of the vocabulary is typically used in France, the course also incorporates words and expressions used in most Francophone countries, and highlights many pronunciation features common in Canadian French (Laurentian and Franco-Ontarian French), such as assimilations, schwa deletion, and negation deletion.

#### Learning Outcomes / Course Objectives

Upon successful completion of this course, students will be able to:

- Demonstrate oral language skills.

- Demonstrate a certain ease in understanding authentic dialogues between French speakers and demonstrate the ability to participate actively in authentic conversations.

- Demonstrate knowledge of pronunciation rules, using them appropriately during recordings and in authentic conversations.

- Recognize, identify and use different language registers in French.

- Explain concepts specific to oral language by answering complex questions concerning vocabulary, grammar and pronunciation.

- Examine various phenomena concerning language variation, and oral language in general.

- Compare and explain linguistic phenomena in oral English and French.

- Demonstrate the ability to understand, use and apply theories of oral language (syntactic and phonetic rules) and to apply new vocabulary in exercises and authentic written and spoken conversations.

- Demonstrate an appreciation of French culture, explaining French cultural phenomena, and comparing them to particular phenomena in a Canadian context.

- Apply knowledge and skills in oral and written comprehension and production in authentic communication situations.

#### **Texts and Materials**

**Required Text**: Custom Course Book **French 4900A - September 2024 -** Nadine de Moras (to be downloaded from the Brightspace website).

#### Attendance

The students' attendance and participation are essential to their learning in this course. There is no separate grade for attendance. Instead, the participation mark is in the quizzes (14%). Coming to class helps students understand, practice and memorize concepts and vocabulary, and improve pronunciation. This, in turn, reflects on the quizzes and the recordings marks. Students need to come to class prepared, having completed the assigned readings and exercises to benefit from the class practice. Please <u>do not</u> email me if you miss a class: I take regular attendance, therefore if you're not here, I already know. I will not answer emails sent for the sole purpose of giving me such notice, even if it's advance notice.

## Quizzes (14%)

All quizzes are due on Mondays at 12:00pm, before the classes start. Students are welcome to do them earlier. All the information to be learned is clearly explained in the coursebook and the PowerPoint presentations. The class time is for summarizing, explaining, and practicing the most important concepts and vocabulary. The quizzes encourage students to do their homework, come to class regularly, pay attention to activities and provide students with some feedback about what they learned and mastered, and what they did not. The quizzes test the students' preparation, assiduity and mastery of the material. The questions in the quizzes are mainly fill-in the blanks and some multiple-choice questions. The best 7 quizzes (out of 8) will be counted (2% each).

#### Recordings 30% (15% each)

After reviewing the pronunciation rules and practicing in class, you'll read the texts aloud for the recordings. Very detailed comments will help you improve on various points. The aim is to learn, practice and master the basics of French pronunciation and colloquial language. Consider this as an excellent opportunity to improve your oral French. **You CANNOT redo the recordings**. You need to listen to the sound files, come to class, and practice in class. The professor will give you feedback. You can also go to the Western *Centre d'aide en français* for extra practice. Once you practiced this way, you can come during my office hours to practice with me before the recording.

#### 1 written composition (10%)

During the class composition, students will be given a list of words for each chapter and questions.

- 1. They will give synonyms, definitions or translations;
- 2. They will make sentences using these words. The meaning needs to be clear and precise.
- 3. They may answer cultural questions.
- 4. The overall quality of French (grammar and spelling) will also be graded.

## 1 Midterm (15%)

The midterm tests the students' acquisition of the content of the course taught up to the midpoint of the course. Some questions will be taken from the quizzes; others will be taken from the coursebook, the Power Point presentations, and from what was presented and discussed in class.

The format of the midterm can be found at the end of the coursebook and on Brightspace.

## The final exam (30%)

The final exam is cumulative. The content of the whole term will be in the exam. The final exam will have a combination of short and longer answers. Some of the questions may be the same or similar to the ones in the quizzes and the midterm. The questions can test knowledge (short answers, fill-in the blanks), or understanding of a linguistic or cultural concept (explain a phonetic or cultural concept). More details will be given in class with the exact format of the final exam, later during the term.

#### Classroom etiquette and general considerations

- Students are expected to arrive on time to class, stay the whole class and actively participate in the class activities.
- Students are expected to come to class fully prepared: having done the homework, which is clearly explained on the website and in the coursebook, in addition to the weekly quizzes, and to come to class <u>with their printed coursebooks</u>.
- If students are going to be absent for one class, they should NOT contact me. I take attendance; thus, I know that you are absent.
- However, if students are absent for a long period of time, or drop the course, they are expected to let the instructor know.
- If students contact their professor, they are expected to be polite, use VOUS, **use their UWO email**, write the correct Professor's name, and indicate their student number if related to more important matters.
- Students have the responsibility of completing their work each week and have opportunities to improve their grades during the term. <u>There is no possibility of doing extra work</u> at the end of the year or **increasing the final grade** to compensate for missed work or low marks.

## Accommodation for quizzes

All quizzes deadlines have an automatic 48-hour 'grace period'. That is, if you cannot make the original deadline set (Mondays, 12:00pm), you will have an additional 48-hour period during which you can still submit the assessment without requiring any academic consideration from Academic Counseling, or permission from the instructor, and without any late penalty. There is no limit on the number of quizzes for which you 'use' the 48-hour grace period. So, if you need some or all of that extra 48 hours to get these assessments submitted, simply take it—no questions asked. Beyond that 48-hour grace period, late submissions will not be accepted. Note that the 48-hour grace period **does NOT apply to the other assessments**.

The submission deadlines for quizzes already include flexibility in three forms:

- 1. The 48-hour grace period.
- 2. The best 7 quizzes out of 8 (and possibility of missing one quiz without penalty).
- 3. The early availability of quizzes, and the possibility of submitting the quizzes in advance.

This is why the instructor reserves the right to deny extra academic consideration for quizzes which are submitted following the end of the period of flexibility (after the 48-hour grace period). Thus, extra accommodation will not be accepted for quizzes, and quizzes are blocked after the deadline.

All academic consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, students can submit <u>ONE</u> recording up to 24 hours late without supporting documentation and without penalty. The midterm and the class compositions always require formal supporting documentation when requesting Academic Consideration.

#### **Evaluation Scheme for Missed Final Exam**

If you miss the Final Exam, please contact the Academic Counselling office of your Faculty of Registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a "Multiple Exam Situation" (e.g., more than 2 exams in 23-hour period, more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the final examination has been deferred. See the Academic Calendar (Special Examinations), especially for those who miss multiple final exams within one examination period.

Note that supporting documentation is **always** required for academic consideration requests for examinations scheduled by the office of the registrar (e.g. December and April exams). When a student receives academic considerations or academic accommodations which overlap with the built-in flexibility of the assessment, the longest period of accommodation will determine the deadline. The built-in flexibility of the assessment should not be taken to extend any considerations or accommodations.

## Use of Generative Artificial Intelligence (AI)

In this course, students written assessments (composition, midterm) are done in class, proctored with no documents allowed. Thus, the question of the use of AI does not apply.
