How do creative practices respond to, and attempt to intervene within, historical and ongoing forms of injustice, including in our contemporary moment? How can the arts *move* us to be, and do, otherwise? This course looks to examples of feminist artivism (across visual art, media, spoken word performances, poetry, film, and theatre, as potential examples) in relation to some major and lesser known local and global social justice movements and issues. Together we will work to understand and assess various relations between art and aesthetics, feminism, politics, action - and cultural change.

Submitting Assignments: Please submit all written assignments to Turnitin.com through the course OWL links. (You may also be required to hand in hard copies of written assignments in GSWS 3316G; if so, I will make this clear in the assignment instructions.) Here's the statement on use of Turnitin from the University:

"All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under licence to the University for the detection of plagiarism. All papers submitted will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licencing agreement currently between the University and Turnitin.com (http://www.turnitin.com)." (http://www.uwo.ca/univsec/handbook/exam/courseoutlines.pdf)

Deadlines are registered as the date/time these assignments are due to Turnitin, and late penalties are assessed based on the submission time to the Turnitin site – so please don't forget to load your paper to Turnitin on time! Avoid the 2%/day late penalty by seeking academic consideration as appropriate (see below).

Essays not submitted to Turnitin will receive grades converted to 0. You cannot submit assignments in GSWS 3316G prepared for other courses.

Attendance in Classes: It's important that you "attend" class (in person or online as relevant to the course delivery format under covid conditions) in order to succeed in the course. I expect you to have read the assigned materials prior to each class and to be prepared to participate in discussions. Participation includes demonstrating familiarity with the course readings, asking engaged questions, contributing to discussion in a thoughtful way (this *always* allows for respectful dissent), and being a respectful listener. Please note that the Department reserves the right for instructors to give reading quizzes as part of the participation grade if it seems necessary (i.e., if class members do not seem to be keeping up with the reading). Hopefully we won't need this :) No single component (attendance, discussion, questions, etc.) determines your overall participation grade.
