Investment Objective

The objective of the Fund is to achieve long-term financial outperformance with greater sustainability impact by investing globally in companies whose activities are linked to sustainable investment themes.

Investment Strategy

The Fund invests in companies which qualify as a sustainable investment and whose economic activity contributes positively to the achievement of one or more of the United Nations 17 Sustainable Development Goals ("SDGs") and/or reduces the risk of not achieving one or more of the SDGs, while ensuring that the portfolio companies follow good governance practices. The Fund seeks portfolio alignment with a 2 degree Celsius global warming scenario.

Risk: Moderate-High

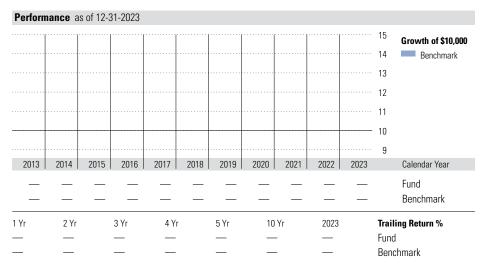
The main investment risks for this Fund include: market risk, currency risk, derivative risk, foreign investment risk, active management risk and specialization risk.
