Reviews should be between 1000 and 1500 words in length including bibliography and footnotes, and should be constructed in a typical book review format as outlined in the MLA style guide. Those interested in submitting a review should send me their preferred title and author for approval in order to avoid duplicating submissions. Books reviewed must be scholarly titles that relate directly to the chosen theme of the fall issue and which were published between 2013 and the present. Please refer to the submission guidelines that follow for formatting instructions. Please note that *The Scattered Pelican* does not provide complementary copies of the books for review, but the majority of the titles in the suggested bibliography are available in major university or public libraries.

Margins 1" (2.54 cm) all around; Times New Roman 12 points; double-spaced except for block quotations, which should be single-spaced. 4. MLA style for in-text citations and bibliography. Multiple works from a single anthology properly cross-5. referenced. Refer to the MLA Handbook for Writers of Research Papers, 7th ed. or Western University Library style guides at https://www.lib.uwo.ca/services/styleguides.html. 6. 7. Leave one space after concluding punctuation marks before starting a new sentence. 8. 9. Where applicable, divide papers into appropriate sections with bold headings. 1. Page numbers in header.
