DESCRIPTION

We spend a considerable portion of our lives in the digital world. What moral considerations ought to guide our conduct as digital citizens, given the possibility that online behaviour is morally distinct from real world behaviour? This class will engage materials that address the philosophical issues raised by these two questions: Specifically: What's the relationship between our virtual identities and our physical identities? How is online activity changing our interpersonal relationships? What are our rights and responsibilities toward others in the digital world? How do we trade between the potentially conflicting values of anonymity and accountability? How do we balance copyright claims against demands for open access? Is piracy always wrong? Does a hacker's code of ethics make any sense? How should we respond to sexism, racism, homophobia and other forms of hate and exclusion in online communities?

TEXTS

All the readings for this course will be made available through OWL

OBJECTIVES

The primary objective of this course is to help students improve their critical thinking skills. Specifically, students should expect to improve their abilities to understand the arguments made in the readings and respond with arguments of their own in their online discussion posts, their online participation, and their term papers.

The secondary goal of the course is to familiarize students with recent attempts by scholars to identify and address the ethical issues that emerge in our increasingly digital lives. This goal will be satisfied by testing student comprehension of the materials with online quizzes, and on the final exam.

REQUIREMENTS

Online Quizzes: 15% (11 quizzes, worth 1.36% each) Online Discussion Posts: 20% (two 400 – 600 word posts, worth 10% each) Online Discussion Participation: 10% (8 responses, worth 1.25% each) One 1200 – 1300 word term-paper: 25% Final Exam: 30%

COURSE POLICIES

1. Extensions

If you fail to meet the submission dates for the two essays, extensions may be granted only as a result of a petition to the Academic Counselor of the student's faculty (barring a student's use of the new 48 hour 'Self-Reported Absence Form', outlined below). **Instructors have no authority to waive this requirement, and any unofficial arrangements they make with students will not be respected by the administration.**

<u>Discussion Responses/Participation</u>: A failure to respond with the required number of replies (four in both Units 2 and 4) to your group mates' discussion posts before the deadline specified on the course syllabus <u>cannot</u> be made up.

<u>Term Papers</u>: Late term papers (due on Monday December 2nd, 2019) will lose 5% (out of 100) for each day they are late. In accord with UWO Senate guidelines, **no term papers will be accepted after the last day of classes, i.e., Thursday December 5th, 2019. ANY PAPER NOT SUBMITTED BY THIS TIME WILL (regrettably) RECEIVE A GRADE OF 0.**

This option should be used in situations where the student expects to

resume academic responsibilities within 48 hours or less.

EVALUATION OF ACADEMIC PERFORMANCE

At least three days prior to the deadline for withdrawal from a course without academic penalty, students will receive assessment of work accounting for at least 15% of their final grade. For 3000- or 4000-level courses in which such a graded assessment is impracticable, the instructor(s) must obtain an exemption from this policy from the Dean and this exemption must be noted on the corresponding course syllabus. In rare instances and at the Dean's discretion, other courses could receive a similar exemption, which also must be noted in the course syllabus.

COURSE ASSIGNMENT
