**Textbook:** Linear Algebra with Applications, by Jeffrey Holt, published by W.H. Freeman and Company, New York, 2rd edition (2017).

**Contents:** Chapters 1-6 of this text are pretty much the topics covered in the first linear algebra course and are thus required. This course will cover the remaining chapters 7-11, plus some possible extra materials as a need is seen.

General vector spaces, inner product and orthogonality, Gram-Schmidt process, Diagonalization of symmetric matrices, QR factorization and singular value decomposition of matrices, linear transformations, minimum/maximum of quadratic forms, constrained optimizations, least squares of errors, interpolations by polynomials and trigonometric functions and applications.
