DESCRIPTION

This course introduces students to the attempts by scholars to understand whether, and the degree to which, humans can be held responsible for their actions. Do humans have ethical duties and responsibilities toward one another or themselves? If so, on what grounds do they have those ethical duties? The primary focus of our survey of the scholarly responses to these questions will consist first in a review of the dominant concerns in meta-ethics, followed by a survey of the most prominent ethical theories.

OBJECTIVES

This course seeks to achieve one primary goal, namely, to introduce students to and/or build upon a set of standard philosophical skills. Using the readings, lectures, and essay assignments this course will help students to identify what it is that makes the set of reasons that support the conclusions of an argument either convincing or implausible by requiring them to formulate well-reasoned responses.

REQUIREMENTS

15% - In-Class test

60% - two 1250 - 1500 word essays, worth 30% each* 25% - Final Exam (to be scheduled by the registrar during the 2018 mid-year examination period, i.e., December $10^{\text{th}} - 21^{\text{st}}$, 2018)

* Late papers will be assessed a 5% penalty on the first day, and will incur an additional 1% penalty for each subsequent day until the penalty reaches 50%. After that time, a grade of 0 will automatically be recorded. No papers will be accepted after the last day of classes, i.e., Friday December 3rd 2018.
