DESCRIPTION

Ethical issues in health care represent some of the most pressing issues faced by Canadians. In this course, students will learn about the most important bioethical issues across the human life span, from conception to death. At what point in development do human beings acquire moral status? Is it ethical to select human embryos for desirable features? When patients and physicians disagree about treatment, who has the final say? What do we owe the global poor? And can we harvest organs for transplantation from the dead? Diverse philosophical approaches to these—and other—bioethical problems will be considered with an emphasis on the role of moral reasoning. Readings and in-class lectures will be supplemented with discussion of real-world bioethics cases. The course is recommended for students considering a career in the health professions, or those who seek a deeper understanding of contemporary social issues. No prior background in philosophy is assumed.

OBJECTIVES

The course has three main objectives. First, the course will familiarize students with important topics in bioethics across the human lifespan. Second, it will expose them to a variety of philosophical approaches to key bioethical problems. Third, it will give students the opportunity to apply these differing philosophical approaches to real cases in bioethics.

ASSESSMENTS

Your grade for the course will be based on five (5) written case analyses, quizzes, discussion forum posts, and a final exam.

1. Case analyses

Due dates: see weekly schedule.

Length: No more than 500 words.

Format: Write an analysis of an assigned contemporary ethics case, drawing on course readings. Further instructions can be found on the OWL website.

Value: 30% of final grade (6% for each case analysis).

Submission instructions: Please submit a digital copy in <u>.doc or .docx</u> format to the OWL website. There is a <u>late penalty of 5% per day</u>.

2. Quizzes When: every week Value: 20% of final grade

Format: Quizzes are based on the lectures and readings. You will be asked three multiple choice questions and three true or false question about key concepts and arguments.

Missed quizzes: If you miss a quiz <u>you cannot take it at a later date</u>. If an academic consideration is received from an academic counsellor, the missed quiz will be removed from your grade and the remaining quizzes reweighted accordingly. If no academic consideration is received, you will receive a grade of 0% for the quiz.

3. Discussion forum posts

When: every week

Value: 20% of final grade

Format: Discussion forums questions are based on the lectures, readings, and the case of the week. You will be asked to respond to two questions. Further instructions can be found on the OWL website.

Missed discussion post: If you miss a discussion forum post, <u>you cannot write one at a later date</u>. If an academic consideration is received from an academic counsellor, the missed post will be removed from your grade and the remaining posts reweighted accordingly. If no academic consideration is received, you will receive a grade of 0% for the post.

4. Final exam

When: During exam period Value: 30% of the final grade Format: Similar format to the quizzes, discussion forum questions, and case analysis questions.

<u>AUDIT</u>

Students wishing to audit the course should consult with the instructor prior to or during the first week of classes.

EVALUATION OF ACADEMIC PERFORMANCE

At least three days prior to the deadline for withdrawal from a course without academic penalty, students will receive assessment of work accounting for at least 15% of their final grade. For 3000-or 4000-level courses in which such a graded assessment is impracticable, the instructor(s) must obtain an exemption from this policy from the Dean and this exemption must be noted on the corresponding course syllabus. In rare instances and at the Dean's discretion, other courses could receive a similar exemption, which also must be noted in the course syllabus.

COURSE ASSIGNMENT

Instructors will be required to return assignments to students as promptly as possible with reasonable explanations of the instructor's assessment of the assignment.
