**DESCRIPTION**

◀ In this course, we will survey philosophical approaches to evil through the history of Western philosophy, including readings from the Book of Job, St. Augustine, Leibniz, Voltaire, Bayle, Hume, Kant, and Schopenhauer, as well as selections from more contemporary texts. We will consider evil as a theological problem (i.e., the notorious *problem* of evil), the metaphysical character of evil (i.e, what is it, if it is anything at all?), and philosophical responses to the *fact* of evil and suffering, especially pessimism (the view that this is the “worst of all possible worlds”). ▶

**TEXTS**

◀ A course-pack containing all of the readings for the course will be made available to students. ▶

**OBJECTIVES**

◀ This course will (1) serve to introduce you to some of the principal figures in the Western philosophical canon through consideration of their discussions of evil and related topics; (2) will help you develop and improve critical thinking, analytical, and argumentative skills; and (3) provide you with experience in writing expository and argumentative papers. ▶

**METHOD OF EVALUATION**

Mid-Term Examination (20%)  
Short Essay Assignments (2 x 20%)  
Final Examination (40%) ▶
