COURSE DESCRIPTION

 This course is an introduction to the philosophy of mind. It covers a broad range of traditional questions in this field, such as:

- What is a mind or a mental state?
- Can mental states be explained in the same way as other things (such as the motion of physical bodies)?
- Do we really know what others feel or experience?
- What is the relationship between sensory experience and thought?
- What is a person and under what conditions does a person continue to exist?
- Does the determinism of physics imply that we have no free will?

Please note that this is a fully online, asynchronous course based on short online videos. Access to the Internet on a weekly basis is required. 

LEARNING OUTCOMES

 By the end of this course, you should be able to explain and evaluate the main philosophical arguments and positions discussed in this course both orally and in writing. You should acquire and/or improve upon general skills useful for critically engaging with philosophical ideas as well as other pursuits, including analyzing, and critically evaluating arguments, skills involved in effective oral and written communication, and fruitful engagement with peers.

METHOD OF EVALUATION

The sole method of evaluation for this course is a series of mini essays of maximum 850 words each. Each mini essay addresses a relatively narrow question about the course materials. In total, you will have **five opportunities** to write mini essays. **Your course grade will be the average of your three best mini essays.**

Example

You have written five mini essays, for which you have obtained the following grades: 70%, 80%, 50%, 90%, 80%. We discard the 50% and 70% essays. The average of the remaining three is 83.3%. This would be your course grade before rounding.

In principle, you can have a grade of 100% by writing only three mini-essays, but we recommend writing all five. **Many students who have little practice writing essays find that they need some practice before their results correspond to their grade expectations.**

The essay due dates will be spaced roughly equally throughout the term.

This course implements flexible deadlines in lieu of minor academic considerations. By default, we grant a grace period of 3 days (that is, 72 hours) for all essay submissions. You do not need to say anything if your essay is handed in 3 days or less after the official deadline. If it is submitted later, however, you will be assessed a penalty of 2% per day, and we will not accept your essay if it is more than 2 weeks late unless you have a major academic consideration from your counsellor. If you only have an academic consideration for 3 days or less, we will not grant an extension since this is already granted as part of the grace period.

In this course, the use of AI (automatic translation tools, grammar checkers, ChatGPT...) is prohibited. If unauthorized AI use is suspected, the instructor will ask for **research notes, rough drafts, essay outlines**, and other materials used in **preparing assignments**. Students are expected to **retain** these materials until after final grades have been entered. In the unlikely event of concerns being raised about the authenticity of any assignment, students may be asked to produce these materials; an inability to do so may weigh heavily against them.

ACCOMMODATION

Students seeking academic accommodation on medical grounds for any missed tests, exams, participation components and/or assignments worth 10% or more of their final grade must apply to the Academic Counselling office of their home Faculty and provide documentation. Academic accommodation cannot be granted by the instructor or department. Documentation shall be submitted, as soon as possible, to the Office of the Dean of the student's Faculty of registration, together with a request for relief specifying the nature of the accommodation being requested. ACADEMIC CONSIDERATION

Students may request academic consideration in cases of extenuating circumstances – that is, personal circumstances beyond the student's control that have a substantial but temporary impact on the student's ability to meet essential academic requirements.

1. Requests for academic consideration are made to the Academic Advising office of Faculty in which the student is registered.
2. Requests for academic consideration include the following components:
 - a. Self-attestation signed by the student;
 - b. Indication of the course(s) and assessment(s) relevant to the request;
 - c. Supporting documentation as relevant

Requests without supporting documentation are limited to one per term per course.

Documentation for medical illness, when required, includes the completion of a [Western Student Medical Certificate \(SMC\)](#) or, where that is not possible, equivalent documentation, by a health care practitioner. Requests linked to examinations scheduled by the Office of the Registrar during official examination periods as well as practice laboratory and performance

tests typically scheduled in the last week of term always require formal supporting documentation.
